

Water Unites – Strengthening Regional Cooperation on Water Management in Central Asia

International Conference

Almaty, Republic of Kazakhstan 17 - 18 November 2008

Introduction

The Conference is organized by the United Nations Economic Commission for Europe (UNECE), the Government of Germany, the Executive Committee for the International Fund for the Saving of the Aral Sea (EC-IFAS) and the United Nations Development Programme (UNDP). It is hosted by the Kazakh Executive Board of IFAS and the Government of the Republic of Kazakhstan.

The main objective of the Conference is to assess short- and long-term challenges in the field of cooperative water management in Central Asia with the participation of high-level representatives of the countries of the region, the UN, the European Union, regional organizations and other members of the international development community, in order to generate more coherent, efficient and better targeted action to address these challenges.

Participants will discuss environmentally and water-related aspects of the Joint UN Agency Central Asia Regional Risk Assessment, prepared by the Regional Bureau for Europe and CIS of the UNDP.

A key element of the Conference will be the presentation of a Modular Project, developed by GTZ with the support of the Federal Foreign Ministry of Germany and UNECE under the "Berlin Water Conference process", launched on 1 April 2008 by Federal Foreign Minister Frank-Walter Steinmeier. Representatives of Central Asian states as well as decision-makers and experts of regional organizations responsible for water management (IFAS and ICWC) will be invited to comment on the Project and signal their willingness to participate in its implementation. Representatives of the European Union (the Italian Coordinator of the water and environment pillar

of the Central Asia Strategy of the EU and the Commission) will present the water and environment pillar of the EU Central Asia Strategy and the EU approach to water cooperation in Central Asia.

The inauguration of the Executive Committee of the International Fund for Saving the Aral Sea will take place on the second day, followed by the launching of the East Caspian Assessment and its follow up by the Environment and Security Partnership, and the presentation of the Cooperation Framework for IWRM by the European Commission and international organizations. The final session will discuss a number of legal and institutional issues, raised by participants of the Berlin Conference "Water Unites", including the need to modernize the legal and institutional basis of cooperative water management in Central Asia.
