The third Steering Committee meeting under the National Policy Dialogue on integrated water resources management in Kyrgyzstan

Bishkek

October 8, 2009

The representatives of Kyrgyz Republic, Republic of Kazakhstan and international organizations took part in the third Steering Committee meeting. The list of participants is attached (Annex 1).

Participants of the Steering Committee Meeting have discussed and made the following decisions and recommendations on the issues of Agenda:

1. To take into account the information on the meeting of project support mechanisms for implementing the Protocol on Water and Health (Geneva, July 1 2009). To send a letter, based on preliminary consultations, from the Steering Committee to the Norwegian MFA with a request for support under the Dialogue.

2. To instruct the Water Management Department to initiate the process of considering abilities of ratification the Protocol on Water and Health at the national level and in established order, provided by KR legislation.
 - 2.1 Management of the steering Committee should assist the preparation of the SWAT-analysis of the Protocol on Water and Health, with support from the UNECE.
 - 2.2 To representatives of interested ministries and agencies - participants of the dialogue to prepare and submit to the Water Management Department a list of questions on the Protocol on Water and Health until November 1, 2009 to obtain clarification from the UNECE secretariat
3. To take notice of the information on establishment of river basin council in the Chu River basin that were created under the Dialogue (a copy of the Council establishing presented in Annex 3). To note with pleasure the experience of good cooperation on this question in the process of Dialogue with the World Bank Improving Water Management in Kyrgyzstan.
4. Consider the possibility of using the experience of creating donor advisory group under the Chu-Talas Commission under the Dialogue
5. To welcome sharing the experience between the international and other organizations in implementing integrated water resources management in Kyrgyzstan in the framework of the National Water Policy Dialogue. To ensure further implementation of regular session on this topic at each Steering Committee meeting.
6. To place the information about the process of National Water Policy Dialogue in Kyrgyzstan in the sphere of integrated water resources management on the web page of the Department of Water Management: WWW.WATER.KG
7. To approve in general the plan of activities of Steering Committee meeting in 2010 and preliminary plan for 2011. To apply to the UNECE with request for finding additional funds to carry out the planned activities. The next Sreering Committee meeting within the frame of National Water Policy Dialogue in Kyrgyzstan in the sphere of integrated water resources management to be held in summer 2010 in Bishkek.
