7 September 2011

1. Take into account the information on approaches of creation of river Basin Plans have been discussed on the Fifth Coordinating Council Meeting.
2. Take into account the information on the main goals and objectives of the Protocol on Water and Health for the UNECE Convention on Protection and Use of Transboundary Watercourses and International Lakes.
3. In accordance with decision of the Fifth Coordinating Council Meeting for organization of Working Group on development of Basin Plan in the Chu river basin and setting of target indicators in the context of the Protocol on Water and Health, to submit a requests to the relevant ministries and agencies. Provide for participation of representatives of relevant international projects in the Working Group.
4. In the period before the second Working Group Meeting the Experts will prepare:
 - (a) in the Context of development of Basin Plan in the Chu river basin:
 - proposals on structure of the document governing the development of the Basin Plan;
 - proposals on structure of the database necessary for development of Basin Plan in the Chu river basin.
 - (b) in the Context of the Protocol on Water and Health:
 - proposals on selection of high-priority target indicators in the Chu basin, based on analysis of existing problems in each sector;
 - review in accordance with the list of issues to be addressed in the process of selection of target indicators.
5. The results named in paragraph 4 to be presented on the second Working Group Meeting on development of Basin Plan in the Chu river basin and setting of target indicators in the context of the Protocol on Water and Health.
6. The second Working Group Meeting to be held the day before the Sixth Coordination Council Meeting, scheduled for late November-early December 2011
