1. **Page 69, fourth full paragraph** – *delete* first and second sentence:

Even so, a total of 6 per cent of urban residents and 21 per cent of the rural population – some 5 million people – have no access to safe drinking water. In some regions of the country (Bukhara, Khorezm, Karakalpakstan), the water supply system coverage stands at only 20-25 per cent.
