





## **H@C** of National Urban Agenda


- 1. Housing is inseparable from urbanisation
- 2. Housing is a socioeconomic development imperative
- 3. Systemic reforms, strong institutions and long-term policy and finance are needed to enable access to adequate housing for all
- 4. A simultaneous twin-track approach with curative and preventive policies should be promoted
- 5. Housing and slum upgrading policies should be accompanied by national strategies
- 6. Human Rights principles and standards are of outstanding relevance for urban development to lead to socially sustainable and inclusive cities




# **H@C of CITIES**

- 1. Housing is an integrated element of urban planning
- 2. Urban planning should be geared toward the progressive realisation of the right to adequate housing for all
- 3. Place matters spatial integration
- 4. Urban planning and legislation should contribute to maximize affordability of housing and spatial inclusion
- 5. Sustainable housing is a litmus test of sustainable cities
- 6. A continuous, participatory and inclusive urban planning process should be the starting point
