Opening Session



On 9 July 2014, the Secretary-General appointed Mr. Christian Friis Bach of Denmark as the next Executive Secretary of UNECE. Mr. Bach brings to the position a combination of deep knowledge in international economy and development affairs coupled with innovative and results-oriented leadership. Mr Bach came from a position as Member of the Danish Parliament and Head of the Parliamentarian Group for the Danish Social/Liberal Party. He previously served as Denmark’s Minister for Development Cooperation (2011-2013) and Special Advisor to the European Union Commission for the United Nations Global Sustainability Panel (2010-2011). He is Honorary Professor of International Economics and Development at the University of Copenhagen (2009-2014) and has been Associate Professor in International Economics and Development Economics, the Royal Veterinary and Agricultural University (1999-2005).

Mr. Bach has a long history with civil society, notably as the International Director for the DanChurchAid (2005-2010) and as Chairman of the Danish Association for International Cooperation (1997-2001). He also has private sector experience from running a start-up company and has worked as a journalist at the Danish Broadcasting Corporation. Mr. Bach holds a Ph.D. in International Economics (1996), an MSc in Agronomy (1992) from the Royal Danish Agricultural University in Copenhagen and a supplementary degree in Journalism from the Danish School of Media and Journalism.

Born in 1966, Mr. Bach is married and has three children. The family lives on a small farm outside of Copenhagen.

Session 1: How governments support smart city initiatives

1.1 Western countries



Mr. Ingolf SCHAEDLER

Deputy Director General for Innovation
Ministry of Transport, Innovation and Technology, Austria

Since March 2003, Ingolf Schaedler is serving as Deputy Director General for Innovation at the Austrian Ministry for Transport, Innovation and Technology. In this function he is responsible for the development and implementation of the Ministry’s technology policy strategy, its technology programmes and the related R&D infrastructure. On the level of the European Union Mr. Schaedler is representing Austria in various high level committees related to Research and Technology Policy, Satellite Navigation and Space Policy. In December 2010 he has been elected as chairman of the governing board of the EU-Joint Programming Initiative “Urban Europe”.

Ingolf Schaedler studied Economics at the University Vienna and International Law and Politics at Johns Hopkins University, Paul Nitze School of Advanced International Studies, Bologna, Italy.

Before working for the City of Helsinki, as a senior adviser to the deputy mayor, she worked on urban planning issues at the Ministry of the Environment.

Mr. Ferdi LICHER held different managing positions at the Netherlands Ministry of Social Affairs and Employment and the Ministry of Education, Culture and Science since 1991. In 2011 he started as director Knowledge and Exploratory Analysis for the Directorate of General Housing and Construction for the Ministry of the Interior and Kingdom Relations. In this position he is responsible for policy information, research, prognoses and analyses for the medium-long term and for maintaining relations with knowledge institutes, universities and planning agencies.

Mr. Ferdi Licher is also programming director for a national Urban Agenda which aims at improving the economic growth, innovation and quality of life of cities in The Netherlands. This agenda is closely linked to the development of a European Urban Agenda and the Dutch presidency of the EU in first half of 2016.

Tony Mulhall is an Associate Director at the Royal Institution of Chartered Surveyors (RICS), a professional body with over 100,000 members working internationally in the areas of land, property and construction. He is a Chartered Surveyor and Town Planner and has worked in a wide range of areas of planning and property in both the public and private sectors. In his current role he is responsible for the production of a portfolio of knowledge and guidance for practitioners in the planning and development sector. He is actively involved in promoting an understanding of development economics within the planning system and has given evidence to the UK House of Commons Select Committee on Town Centre Planning Policy. He represents RICS in a number of bodies including the International Federation for Housing and Planning (IFHP), and the UN Economic Commission for Europe (UNECE). He is Chair of the Inter-Institutional Flood Group which brings together the main professional bodies in the built environment in the UK engaged with flood risk. He has also been engaged as an adviser to the United Kingdom India Business Council in connection with programmes being developed in India and as an adviser to UK Department for International Development. He has given occasional lectures at a number of universities including Cardiff University, London School of Economics, Oxford University, Nottingham Trent University, University College London.

She has been involved in numerous UN ECE and EU housing activities and Working groups targeted at housing and urban development, and has contributed to several UN ECE and research publications related to urban and housing issues. Since 2013 she acts as chair of the UN ECE Committee on Housing and Land Management.

Janja Kreitmayer McKenzie is an urban development expert and policy advisor at the Ministry for the Environment and Spatial Planning in Slovenia. Ms. Ruzan ALAVERDYAN,

After graduating from the Yerevan State Institute of Architecture and Construction, Mrs. Alaverdyan has worked for twenty years at “Yerevanproject” Institute. She is the author of over 40 architectural projects including: the building of Children’s Library after Khnko-Aper in Yerevan; the project of residential complex built by the American Red Cross; new spatial planning documents for Gyumri that were designed after the earthquake in 1988; as well as projects of other residential, public and industrial buildings.

In 1996-2000 she worked as a consultant at the National Assembly, Department of Economic Analysis, Division of Economic Reforms and Social Policy Analysis, later on becoming the head of the division. In 2000-2001 she held the position of the Deputy Minister coordinating Territorial Administration and Urban Development, and since 2001 she has been holding the position of Deputy Minister of Urban Development.

Mrs Alaverdyan was honored a number of state awards for her productive work and services rendered to the Motherland. She is also the coordinator of the European Landscape Convention implementation in Armenia, besides she has participated in the activities related to the development of the *Spatial Planning: Key Instrument for Development and Effective Governance Handbook* initiated by the UNECE. She is the representative of Armenia in the Committee of Senior Officials (CSO) of Council of Europe Conference of Ministers responsible for Spatial/Regional Planning (CEMAT).

Session 2: How municipalities implement smart city initiatives

2.1 Large cities



Ms. Kristina DELY

Covenant of Mayors, Belgium

Kristina Dely has been heading the Covenant of Mayors Office since its establishment in January 2009. The office – composed of 5 major European network of local authorities – co-ordinates the Covenant of Mayors (www.eumayors.eu) an initiative by the European Commission, whereby ca. 6 000 local authorities from 48 countries have committed to reduce their CO₂ emissions by more than 20% by 2020. Formerly, Kristina was in charge of European Affairs of Energy Cities (www.energy-cities.eu), a European association representing 1000 local authorities from 30 countries. Kristina holds a Master's degree in economy and environmental management from Budapest University of Economics and the Ecole de Management de Lyon.



Mr. Victor CALLISTER,
Assistant Director,
Department of Built Environment, City of London, UK

Victor Callister is the Assistant Director (Environmental Enhancement) for the City of London, where the emphasis is creating the highest possible quality of environment for people in the limited and complex space between buildings. Victor manages a team of professional Town Planners and Project Managers, who deliver projects in partnership with City businesses, usually with complex funding arrangements. Many of these projects are delivering on the security needs of the City, but without compromising environmental quality or movement around the Square Mile. Current work is focusing on integrating tall buildings (including the tallest in Europe) in to the already densely developed districts of the City. Although a Chartered Town Planner, his personal interest is in making projects happen within a complex funding/urban/stakeholder context.



Ms. Ina HOMEIER
Project manager
Smart City Vienna, Austria

Ina Homeier is an architect and has been working for the urban planning department of the City of Vienna since 1994. She was also responsible for land use and district planning for several years, and made an internship at the City of Vienna's liaison office in Brussels. From 1998 to 2001, she represented the City of Vienna at the Directorate-General for Research of the European Commission, where she was responsible for urban planning issues and research projects. In 2001, she returned to Municipal Department 18 – Urban Development and Planning, where she focussed on EU research projects. Later she moved to Portugal for several years, where she was an acting partner in the company Innovation Point SA that focussed on the development of urban strategies and technologies. Since the summer of 2011, she has again been working for Municipal Department 18. She is the project manager of Smart City Wien and coordinates the Smart City activities of the City of Vienna with regard to strategy and content. Several national and EU-funded projects such as CLUE (INTERREG IVC), TRANSFORM (FP7), and Transform+ (KLIEN4) have been implemented and Smart City project

Since early 2013, she supervised the drawing-up of the Smart City Wien Framework Strategy that was adopted by the Vienna City Council on 25 June 2014. She is a member of the Smart City Wien steering group and of the MoU Smart City steering group of the City of Vienna and the Austrian Federal Ministry for Transport, Innovation and Technology. She is also a member of the Vienna Advisory Council for Green Electricity and of the Finance and Market Uptake Group of the EU Smart Cities Stakeholder Platform. For many years, she has been nominated by the European Commission and national funding bodies as evaluator for project applications and for mid-term and final assessments of research projects.</p>

Examples of projects include: City-Zen, Vehicle2Grid, Social Innovation, Smart Citizen Kit, and Smart Lightning. Bram previously led a team within the operations department at Alliander NV (Dutch DSO) and studied at the RSM Erasmus University (MSc in Entrepreneurship).</p>

Deputy Mayor Johansson is also Chairman of Renova, i.e. a municipally owned company that is one of the leading environmental companies in waste management and recycling in Western Sweden.</p>
