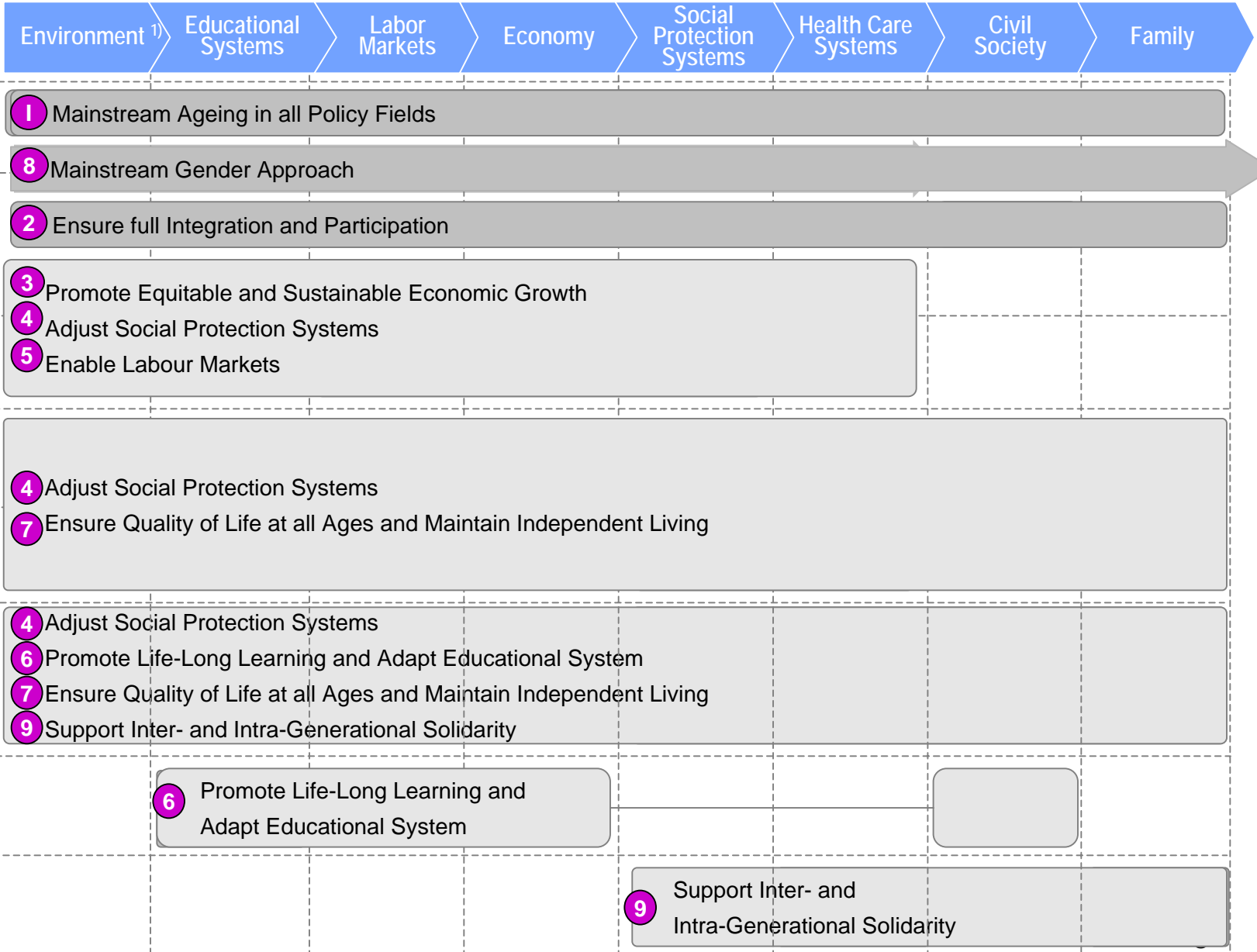

Sectors / Domains



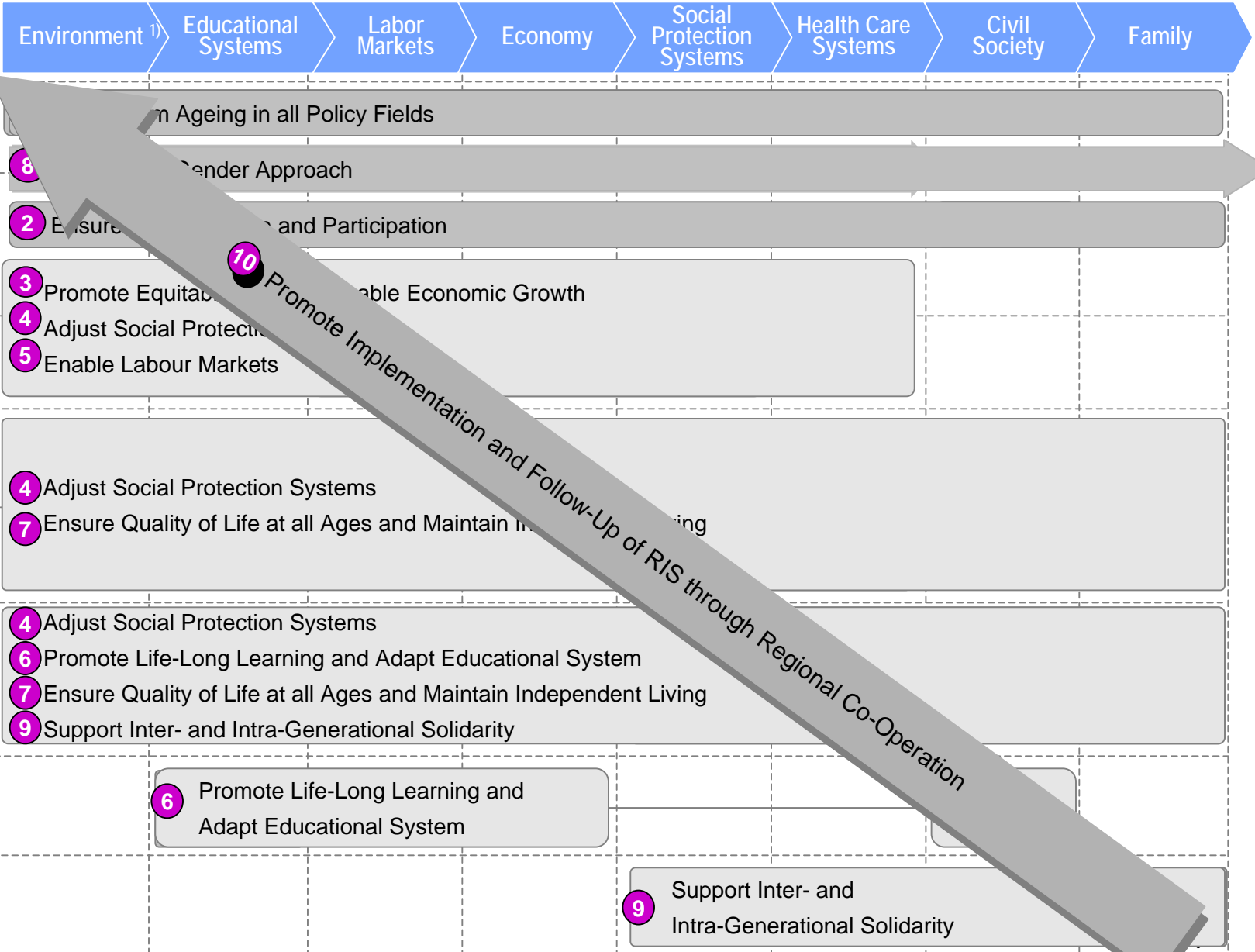
Legend: Primary Focus Extended Focus
