PROVISIONAL AGENDA AND TIMETABLE

PURPOSE OF THE SEMINAR

The main purpose of the Seminar is to help the State Statistical Committee of Ukraine (SSCU) cope more effectively with the distortions to the traditional statistical measures that are occurring as a result of the development of open market economies. The seminar will address globalisation in the context of national accounts and the effect on GDP, GNI and other parts of the accounts. It will also look into classification issues, data collection methods, price indices and methodological guidelines. In order to capture the aspects of globalisation new methods for collecting and recording statistical data on external trade, investment, business activities of enterprises and balance of payments have to be implemented. Therefore, a thorough and timely investigation of these complex issues is necessary.

The seminar is composed of two modules. The first module includes a discussion with the main users of statistics and will be held on 3 July starting at 14:00. The purpose of the session is to raise the awareness of the main users about the role of statistics for decision-making and the challenges that the statisticians face when producing data for an open market economy. The second module will be held on 4-6 July and is a specialised one meant for producers of statistics.

The seminar will be attended by about 60 statisticians of the State Statistical Committee of Ukraine coming from the regional statistical offices and the central office in Kiev, as well as other producers and users of statistics, namely National bank of Ukraine, Ministry of Finance, Customs Service, Ministry of Economy, Cabinet of Ministers of Ukraine, etc. In addition more than 25 foreign participants from EFTA, Eurostat, OECD, UNECE and National statistical offices of Armenia, Bulgaria, Canada, Czech republic, Ireland, Netherlands, Norway, Poland, Russian Federation, Slovenia, Switzerland and the United Kingdom will also attend. It is expected that the discussions at the seminar will lead to making some proposals for short-term solutions and long-term strategies for adapting the statistical system to the effects of globalisation.
