Sixty-seventh plenary session

26-28 June 2019, OECD, Paris, France

INFORMATION NOTE

I. DATE AND VENUE

The sixty-seventh plenary session of the Conference will be held at the OECD Conference Centre, 2, rue André-Pascal, 75016 Paris (see attached map), on 26-28 June 2019. The meeting will commence at 09:30 on Wednesday, 26 June and finish on Friday, 28 June at 12:30. It will take place back-to-back with the 16th meeting of the OECD Committee on Statistics and Statistical Policy (CSSP).

II. VISAS, ACCOMMODATION AND TRAVEL ARRANGEMENTS

For those participants requiring a visa for France, applications should be made to the embassy or consulate of France in the country in which they reside. Visa applications should refer to the 67th plenary session of the Conference of European Statisticians to be held at the OECD Conference Centre in Paris. If a formal invitation letter is required by the embassy, this can be obtained from the OECD secretariat; e-mail: Natasha.Bale@oecd.org.

Participants are requested to make their own hotel and travel arrangements and are advised to book hotel accommodation well in advance of the meeting. III. REGISTRATION & ACCESSING THE OECD

The plenary session of the CES will be held back-to-back with the 16th Meeting of the OECD CSSP. **Registration for the CSSP is a separate process to the CES.** OECD Members should register for the meeting as per the regular process via their Permanent Delegation. Non-member Participants, Observers from International Organisations and Invitees are required to transmit the names (with title, e-mail address and organisation) of delegates to Ms. Natasha Bale (Natasha.Bale@oecd.org) who will register them in the OECD system.

Please note that a few days before the meeting you will receive an email containing a flash code (see example below) which will allow you to gain access to the OECD headquarters. Please check in your spam folder in case you cannot find it. **Please print this flash code mail**

and bring it with you. Access to the Reception Desk will be given to you upon presentation of ID and the flash code.

On arrival at the OECD Conference Centre, delegates must obtain a visitor's badge at the Reception desk, located at the visitors' entrance: 2 rue André Pascal, 75016 Paris. Please be sure to bring photo identification with you (e.g. a passport). **Only delegates who have registered in advance of the meeting will be able to obtain their badges.**

Please arrive well in advance of the start of the meeting to allow sufficient time for the security and registration formalities.

For identification and security reasons, participants are requested to wear their visitor's badge at all times.

To make your way to the conference room, please take the escalator down one floor below the entrance.

The meeting room will be equipped for simultaneous interpretation, which will be provided into and from the three official working languages of the UNECE (English, French and Russian).

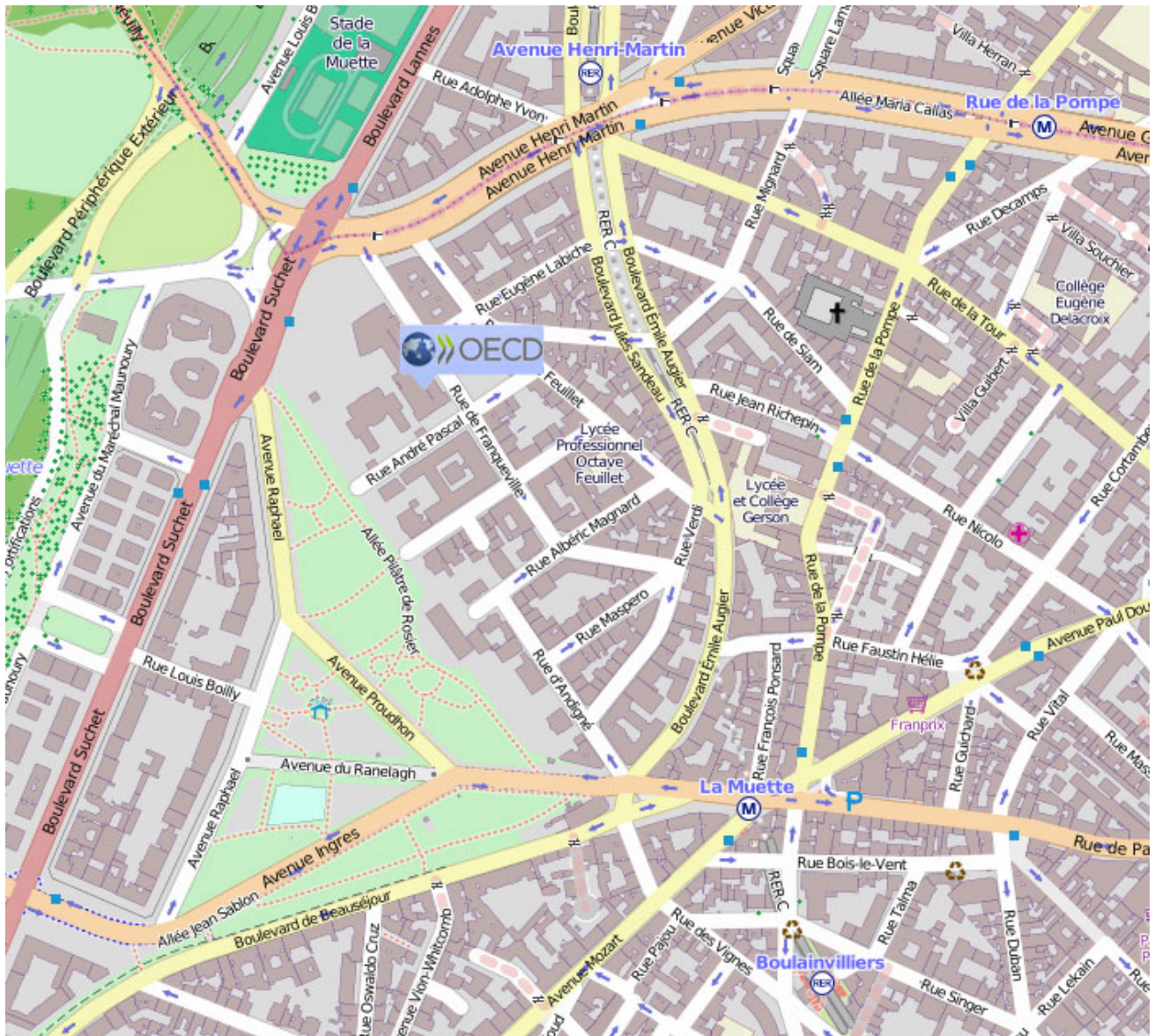
