Implementation of the UNECE Statistical Programme 2014

Note by the Secretariat

Summary

The document provides a short summary of the implementation of the UNECE Statistical Programme 2014. The report is based on the information in an online reporting system, the Integrated Monitoring and Documentation Information System (IMDIS), used within the United Nations secretariat.

The CES Bureau reviewed the outcomes of the UNECE statistical work in 2014 and approved the document.

I. Description of the main accomplishments in 2014

A. Coordination of international statistical work in the Economic Commission for Europe region

1. International statistical work was reviewed in depth in four statistical areas with the purpose to improve inter-agency coordination and eliminate overlaps and gaps in statistical activities in the Economic Commission for Europe (ECE) region. The four reviews addressed the following topics: (i) measuring social protection; (ii) leading, composite and sentiment indicators; (iii) population projections; and (iv) measuring extreme events and disasters. As a follow-up to these reviews, international task forces to improve statistics on population projections and use of official statistics in connection with extreme events and disasters is planned to be launched. A seminar on leading, composite and sentiment indicators will be held in 2015.

2. In 2014, 24 international organizations provided information on their statistical work programmes to the ECE Database on International Statistical Activities (DISA). The classification of International Statistical Activities, originally developed for the DISA database, is being used as a reference at global level, for example by the Statistical Data and Metadata eXchange (SDMX) standard, Paris21, Global Inventory of Statistical Standards, FAO, and several countries. As a result of a review of DISA database in October 2014, the Bureau decided to launch an update of the classification. The classification will be adjusted to include emerging statistical areas, such as climate change-related statistics, composite indicators, geo-spatial data, etc.

B. Methodological work

3. In 2014, the Conference of European Statisticians (CES) and its Bureau endorsed two methodological guidelines that were developed in cooperation with countries and partner organisations, such as Eurostat and OECD: *Gender equality indicators;* and *Recommendations on climate change-related statistics.* In addition, the *CES Recommendations on Measuring Sustainable Development,* endorsed in June 2013, were used in 2014 as a major input to the Open Working Group in developing the draft Sustainable Development Goals, targets and indicators.

5. Five draft CES recommendations were prepared in 2014 for endorsement by the Conference in 2015, namely on global production; statistical business registers; measuring quality of employment; socio-economic conditions of migrants; and recommendations for the 2020 round of population and housing censuses.

6. ECE undertook methodological work in 27 out of 55 statistical areas of the Classification of International Statistical Activities.

C. Capacity building

7. In 2014, ECE carried out 12 training workshops for the countries of Eastern Europe, Caucasus and Central Asia with the support of the regular budget, the budget for technical cooperation, funding from the United Nations development account and external funding sources. In addition, a number of advisory missions were conducted at the request of countries.

8. These activities contributed to progress in areas identified for improvement in Global Assessments of national statistical systems in line with international statistical standards. Global Assessments analyse progress of countries with developing statistical systems in implementing international standards and compliance with the Fundamental Principles of Official Statistics. They are carried out at countries' request jointly with the Statistical Office of the European Union (Eurostat), the European Free Trade Association (EFTA) and the World Bank.

9. In total, 86 per cent of experts who took part in ECE training workshops considered the training to be of high quality and useful for their work.

D. United Nations Economic Commission for Europe Statistical database

10. Progress was made in the availability of high quality macroeconomic, social and demographic statistics in the ECE statistical database. Availability of Millennium Development Goals' indicators and a migration clearinghouse for the countries of Eastern Europe, the Caucasus and Central Asia increases data use.

11. The timeliness, completeness, reliability and comparability of the statistical database were improved. In the end of 2014, in total 156 statistical time series were available in the database.

12. User satisfaction remained high, with an online survey indicating that 85 per cent of users considered the quality of data as excellent or good. In 2014, data downloads remained at the record levels of 2013, when data downloads had increased by one fifth. Automated processes and quality checks improved timeliness and reliability of data. The database also offers quick statistics, maps, graphs, country rankings and profiles.

II. Outputs prepared in 2014

A. Manuals, guidelines, recommendations, compilations of best practices

(a) CES Recommendations on Climate Change-Related Statistics

15. The report presents recommendations that aim at improving existing official statistics to support climate change analysis and reporting on greenhouse gas emissions under the Kyoto Protocol, and highlight areas where official statisticians can contribute with concrete actions.

(b) Indicators of Gender Equality

14. The publication responds to the need to monitor progress towards internationally agreed gender-related policy goals. It assesses indicators' suitability for describing major gender inequalities and for monitoring gender-relevant policies, and their regular availability and comparability across countries.

(c) Final Report on Human Resources Management and Training

15. A final report by the CES Steering Group on human resources management and training provides an overview of work done, and a proposal how the work on human resources could support the modernisation of statistical production and services.

(d) Countries in figures 2015, Europe, Central Asia, North America

16. The publication presents a set of social and economic indicators for each of the 56 UNECE member countries based on the data available in the ECE Statistical Database.

(e) *Measurement of Socio-Economic Conditions of Migrants* (to be submitted to CES in 2015)

17. This publication provides guidelines to countries intending to produce statistics on socio-economic conditions of migrants using existing sources or ad hoc surveys. It harmonises the definitions and describes practices adopted by countries.

(f) Handbook on Measuring Quality of Employment (to be submitted to CES in 2015)

18. The handbook provides practical recommendations to developed and developing countries interested in measuring the quality of employment.

(g) *Guide to Measuring Global Production* (to be submitted to CES in 2015)

19. The Guide deals with global production arrangements that challenge the compilation of economic statistics. The Guide clarifies typology, concepts and definitions of global production and provides guidance in related data collection issues.

(h) International Guidelines on Statistical Business registers (to be submitted to CES in 2015)

20. The Guidelines provide recommendations for developing and maintaining statistical business registers, increasing the efficiency of the statistical production processes and improving comparability of business statistics with business registers.

(i) *Recommendations for the 2020 Round of Population and Housing Censuses* (to be submitted to CES in 2015)

21. The Recommendations provide the basis for collecting reliable, accurate and comparable census data on a core set of census topics, and for harmonizing definitions and classifications.

B. Global Assessments of national statistical systems in the countries of Eastern Europe, Caucasus and Central Asia

22. The Global Assessment of the national statistical system of Mongolia was carried out in 2014, in collaboration with Eurostat, EFTA and the World Bank. ECE also consulted Turkmenistan in their Self-Global Assessment in the course of 2014. Four member States developed a national strategy for sustainable development of statistics in line with recommendations contained in Global Assessments, carried out previously.

23. To address member States' requests for assistance in implementing the recommendations, ECE will start in 2015 with its partners "rotating scheme assessments" and a capacity-building project tailored for the countries of Eastern Europe, the Caucasus and Central Asia in 2014-2017.
