**Draft Programme of Work of the Statistics subprogramme  
for 2016-2017**

**Note by the Secretariat**

*Summary*

*This note presents the programme of work of the Statistics subprogramme for 2016–2017 for consideration by the Bureau of the Conference of European Statisticians.*

*The Bureau reviewed the programme and subsequently adopted it at its meeting of February 2015. This document is then submitted to the Conference of European Statisticians (“the Conference”) and recommended to the Economic Commission for Europe (ECE) Executive Committee (EXCOM) for formal approval.*

## **Introduction**

1. The present document sets out the draft programme of work of the Statistics subprogramme (“the subprogramme”) for 2016–2017. The Bureau of the Conference of European Statisticians is invited to adopt it and recommend to the Executive Committee (Excom) for approval. Any subsequent additional, discontinued or carried over outputs will be reflected in the Integrated Monitoring and Document Information System (IMDIS) used by the Secretariat for the planning, monitoring and reporting on the implementation of the programme. The results of the implementation of the programme of work will be submitted to the Conference and its Bureau in the Programme Performance report for the biennium 2016-2017.
2. The draft programme of work applies a results-based management (RBM) approach, a broad management approach which establishes logical relationship between the hierarchical results (outputs – outcomes – impact) known as ‘results chain’, the resources (human and financial) known as ‘inputs’ and the external factors (strategic, governance, operational, financial) which can prevent from achieving the objective.
3. The outputs/activities in the draft programme of work correspond to those contained in the ECE proposed programme budget for 2016–2017. They fall into the following main categories: (a) meetings and related parliamentary documentation; (b) other substantive activities; and (c) technical cooperation, including advisory services, training courses, seminars, workshops, and field projects.
4. The outcomes/expected accomplishments, with corresponding indicators of achievement and performance measures are presented in Annex I in the form of a logical framework.
5. The details of the proposed publications are provided in Annex II. The overall ECE legislative mandates and those specific for the subprogramme are listed in Annex III.

## **I. Objective, strategy and external factors**

6. The objective of the subprogramme is to improve the quality of official statistics at the national and international levels, and to ensure the coordination of international statistical activities undertaken in the ECE region.
7. The responsibility for the subprogramme is vested in the Statistical Division. The subprogramme aims to improve the quality, coverage and timeliness, as well as coherence of official statistics for evidence-based economic, social and environmental policymaking, and for assessing progress towards international development goals and sustainable development.
8. Coordinating international statistical activities in the region will remain a central component of the strategy under the subprogramme. The strong involvement of national statistical organizations in setting priorities will ensure that the work focuses on addressing the special needs of countries of the region. Cooperation with the statistical services of other UN entities and international organizations will continue in the form of joint meetings and working groups to develop standards and recommendations, and identify good practices.

9. The subprogramme will work on priorities identified by the ECE member States, with a special focus on measuring sustainable development and the post-2015 development agenda; globalization; population, poverty and inequality; promoting modernisation of statistical production; and capacity building. The subprogramme will take into account the recent methodological and technological development in official statistics, including the geospatial information. The work will be undertaken in close cooperation with experts from ECE member States and international organizations in the form of expert groups that perform specific tasks within a set time frame. The work will result in the development of methodological and practical guidelines in statistics, including training materials which will be made available on the web.

10. The subprogramme will provide support and guidance to the ECE member States, particularly those with less developed statistical systems regarding existing United Nations standards and best practices and their implementation at the national level. To this end, the subprogramme will promote the Fundamental Principles of Official Statistics and provide advice on institutional frameworks of official statistics, for example, by conducting global assessments of national statistical systems. The advisory work will be demand-driven, focusing on areas where United Nations standards and recommendations exist, such as population censuses, international development goals, national accounts, prices, business statistics, gender disaggregated statistics, environmental indicators and modernising statistical production.

11. The subprogramme will collect and disseminate statistical information, including on progress towards the achievement of international development goals and gender equality. These statistics will be accessible to the public on the Internet. A quality framework will ensure the relevance, timeliness and user-friendliness of dissemination. The data will help to identify priorities for improvement of the quality and comparability of official statistics.

12. The subprogramme is expected to achieve its objective and expected accomplishments on the assumption that: (a) there is a willingness to cooperate on the part of international statistical organizations, in particular the Organization for Economic Cooperation and Development (OECD), the Statistical Office of the European Union (Eurostat), the Interstate Statistical Committee of the Commonwealth of Independent States (CIS-STAT), the International Monetary Fund (IMF) and the World Bank, as well as on the part of the national statistical organizations of ECE member countries; (b) resource constraints would not hamper the participation of national statistical offices in international work nor impede the implementation of the resulting standards; (c) sufficient donors' support to the work on modernisation of statistical production; (d) development work carried out by national statistical offices continues on key statistical domains; (e) resources are available in order to provide support for the national statistical organizations of countries with less developed statistical systems; and (f) data needed for the ECE statistical database are made available by the national and international statistical organizations free of charge, and the technological infrastructure is sufficient for databases and web dissemination.
