IMPLEMENTATION OF THE UNECE STATISTICAL PROGRAMME 2018

Note by the Secretariat

The document provides a short summary of the implementation of the United Nations Economic Commission for Europe Statistical Programme 2018. The information in the report will be included in an online reporting system, the Integrated Monitoring and Documentation Information System (IMDIS), which is used within the United Nations secretariat for reporting on programme performance.

The Bureau reviewed and adopted the document. The Annex includes the list of meetings organized in 2018.

I. Description of the main accomplishments in 2018

A. Coordination of international statistical work in the UNECE region

- 1. In 2018, 35 international organizations contributed to the statistical work of the Conference of European Statisticians (CES), which coordinates statistical activities in the UNECE region.
- 2. International statistical work was reviewed in depth in four statistical areas with the purpose of improving inter-agency coordination and eliminating overlaps and gaps in statistical activities in the UNECE region. The four reviews addressed the following topics: (i) measuring social exclusion; (ii) use of satellite image data in official statistics; (iii) statistics and data on cities; and (iv) redefining national statistical systems/role of national statistical systems in the new data ecosystem.
- 3. As a result of the in-depth reviews conducted in 2018, the Bureau decided to launch follow-up work on measuring social exclusion. The role of national statistical systems in the new data ecosystem will be discussed further in a CES seminar in June 2019 on emerging roles of national statistical offices as offices for statistics and data. As a follow-up to an earlier in-depth review of gaps in gender statistics in 2017, the Bureau established a new Task Force on communication of gender statistics and decided to conduct an in-depth review on measuring gender identity in February 2019.

B. Methodological work

- 4. The work of the UNECE Statistical Division is fully aligned with SDGs, facilitating country-led reporting of statistics for SDGs in two main ways. First, UNECE is supporting national statistical offices as providers and national coordinators of statistics on SDGs. In 2018, a number of practical tools were prepared to facilitate implementation of the CES Road map on statistics for SDGs in countries. A second pilot of SDG data flows was conducted, involving 40 countries and 6 custodian agencies responsible for SDG indicators. The pilot explored ways to improve data flows and communication between countries and custodian agencies to harmonize SDG statistics.
- 5. Second, the Statistical Division undertakes methodological work and national statistical capacity development to inform policy decisions for the achievement of SDGs through work on demographic, social, economic, and environment statistics. In 2018, UNECE provided methodological support for measuring progress towards SDGs in 20 out of 55 statistical areas of the Classification of International Statistical Activities.
- 6. In 2018, the Conference of European Statisticians (CES) and its Bureau endorsed five methodological guidelines, namely (i) Guidance on data integration for measuring migration; (ii) Measuring international labour mobility; (iii) Guidelines on the use of registers and administrative data for population and housing censuses; (iv) Guidance on modernising statistical legislation; and (v) Guidelines on the use of statistical business registers for business demography and entrepreneurship statistics. UNECE developed these in cooperation with countries and the following partner organizations: Food and Agriculture Organization of the United Nations (FAO), International Labour Organization (ILO), International Organization for Migration (IOM), Organisation for Economic Co-operation and Development (OECD), Statistical Office of the European Union (Eurostat), United Nations Population Fund (UNFPA), United Nations Statistics Division (UNSD), and World Trade Organization (WTO).
- 7. Following the 2017 CES Recommendations on communicating population projections, UNECE established a database on population projection metadata. A High-Level Seminar on Strategic Partnerships was held in April 2018 which led to developing principles and a framework for creating strategic partnerships in official statistics.
- 8. Six draft CES guidelines and recommendations were prepared in 2018 for discussion by the Conference in 2019, namely on (i) recommendations on the role of official statistics in measuring hazardous events and disasters; (ii) Framework on waste statistics; (iii) Guidelines on producing leading, composite and sentiment indicators; (iv) Satellite account for education and training: compilation guide; (v) Recommendations on measuring older populations in institutions and (vi) Strategic communications framework. The guidelines and recommendations are presented in more detail in Section II.A. Recommendations on measuring intra-household power and decision-making were also prepared but will be submitted to the CES Bureau for review in October 2019 and for discussion by the Conference in 2020 to take into account the results of an ongoing pilot testing of the Recommendations.
- 9. Under the auspices of the High-Level Group for the Modernisation of Official Statistics (HLG-MOS) two priority projects were implemented in 2018: Strategic Communication Framework and the second phase of Common Statistical Data Architecture. In addition to the projects, the HLG-MOS Modernisation Groups produced several outputs, including revisions of Generic Statistical Business Process Model (GSBPM) and Generic Activity Model for Statistical Organization (GAMSO), training materials on risk management, and a renewed public Common Statistical Production Architecture (CSPA) Service Catalogue.

C. Capacity development

- 10. In 2018, CES endorsed a new *UNECE Statistical capacity development strategy*, which reinforces the principle that capacity development activities should be user driven. In 2018, UNECE carried out 8 regional and 4 national training workshops for the countries of Eastern Europe, Caucasus and Central Asia with the support of the regular budget, the budget for technical cooperation, funding from the United Nations Development Account and external funding sources. In addition, a number of advisory missions were conducted at the request of countries. With these activities, UNECE supported countries' capacity to develop statistical systems for monitoring progress towards SDGs, to provide gender-sensitive indicators, and to fill gaps identified in Global Assessments of national statistical systems. As indicated by surveys, 97 per cent of experts who took part in UNECE training workshops in 2018 considered the training to be of high quality and useful for their work.
- 11. These activities contributed to progress in areas identified for improvement in Global Assessments of national statistical systems. Global Assessments analyze progress of countries with developing statistical systems in implementing international standards and compliance with the *Fundamental Principles of Official Statistics*. They are carried out at countries' request jointly with Eurostat and EFTA. In 2018, the Global Assessments of national statistical systems in Armenia, Republic of Moldova and Uzbekistan were completed, and the Global Assessment of national statistical system in Georgia was launched. The reports of the Global Assessments completed in 2018 will be released in early 2019.
- 12. To address member States' requests for assistance in implementing the recommendations, UNECE is carrying out two United Nations Development Account (UNDA) projects¹ to strengthen the capacity of countries for the sustainable development of statistics in the sub-region. UNECE also carries out some externally funded projects, for instance a project funded by the World Bank to "enhance coherence and integration of economic and social statistics in support of the implementation of 2008 System of National Accounts (SNA)".

D. UNECE statistical database

- 13. Progress was made in the availability of high quality macroeconomic, social and demographic statistics in the UNECE statistical database. The country overview tables were among the most actively used data along with gender and economic statistics.
- 14. Downloads of statistical data from the UNECE statistical database consistently grew, and the share of downloads via mobile devices has also increased. In 2018, improvements made in the timeliness and reliability of data along with the availability of quick statistics, maps, graphs and country rankings have attracted new users.

The title of the UNDA 9th tranche project is "Supporting the implementation of the global assessment recommendations in the countries of Eastern Europe, Caucasus and Central Asia", and the title of the UNDA 10th tranche project is "Programme on statistics and data" to build countries' capacity for monitoring progress towards SDGs.

II. Outputs prepared in 2018

A. Manuals, guidelines, recommendations and compilations of best practices

- 15. The Conference of European Statisticians and its Bureau endorsed the following guidelines and recommendations in 2018:
 - Guidance on data integration for measuring migration describes good practices and provides practical guidance for integrating different data sources to improve the measurement of immigration, emigration and net migration;
 - Measuring international labour mobility provides practical guidance on the definitions, methods and data sources that can be used to measure labour mobility, and includes country case studies;
 - Guidelines on the use of registers and administrative data for population and housing censuses cover operational, practical, technical and legal aspects of using multiple data sources for censuses, in particular register and administrative data. They also provide methods and good practices for measuring coverage and quality of the various sources;
 - Guidance on modernizing statistical legislation defines common elements and requirements for modern legal frameworks to guarantee flexibility, independence, integrity and accountability of national statistical systems and high quality of official statistics;
 - Guidelines on the use of statistical business registers for business demography and
 entrepreneurship statistics provides definitions and guidance on the compilation of
 key business demography indicators, and linking statistical business registers with
 information from other sources to produce entrepreneurship indicators;
- 16. UNECE Task Forces prepared the following six statistical guidelines for submission to the 2019 CES plenary session for endorsement:
 - Recommendations on the role of official statistics in measuring hazardous events and disasters clarify the role of official statistics in providing data related to hazardous events and disasters, and identify practical steps how national statistical offices in coordination with national agencies responsible for disaster management can support disaster management and risk reduction;
 - Framework on waste statistics helps to harmonize international waste statistics, provide better information for managing waste and for monitoring implementation of important waste-related policy frameworks;
 - Guidelines on producing leading, composite and sentiment indicators provide
 guidance on good practices for national statistical offices in producing leading,
 composite and sentiment indicators. The guidelines clarify the possible roles of
 statistical offices in producing such indicators and provide operational guidance for
 the offices that produce or consider producing these indicators;
 - Satellite account for education and training: compilation guide provides guidance on compiling this satellite account based on the results of pilot testing of the account in countries with different economic circumstances and data availability;
 - Recommendations on measuring older populations in institutions provide standard definitions and classifications of "institution" and "institutional populations" as they

- pertain to older people, and provide guidelines for statistical offices on how to include such populations in the production of statistics on ageing-related topics;
- Strategic communications framework provides advice and material to support the
 implementation of strategic communication frameworks by official statistics
 organisations. It addresses questions of branding, crisis and issue management and
 necessary skillsets, and includes a communication maturity model.

 - Macroeconomic data (national accounts main aggregates, industrial production, labour force, wages, price indices, purchasing power parities, exchange rates, and globalization indicators);
 - Social and demographic data with gender breakdown (population, fertility, families
 and households, work and the economy, education, public life and decision making,
 health and mortality, crime and violence, science and ICT, and life balance);
 - Transport and forestry statistics provided by other UNECE Divisions;
 - Clearinghouse for migration statistics for the CIS countries.
 - Country overview tables and tables with a country ranking and country profiles, charts and maps.
