- **A roadmap, indicating paths and milestones on the road to implementation of the standards (GSBPM / GSIM / GAMS0 / CSPA) in the context of the MMM**

Early implementers

- Travel permission from Top Management
- Map with a recommended path
(**Recommended practises**) by experts
- **Work plan**: who, how, when, checkpoints
- **Evaluation**: what resources did we use and what we recommend for the next action
- Meeting places where they can exchange experiences with other implementers



Some Supporting Instruments

- under development

- **Modernisation Maturity Model: Maturity levels, dimensions and self-assessment criteria per modernisation standard**
 - **Maturity Assessment Template:** Template for documentation of the assessors, standards assessed, current and target maturity levels for the entire organisation/individual business units/statistical domains
- **Gap Analysis Template:** Description of gaps detected between the current and target maturity levels per standard
- **Recommended Practises:** Recommended practises to move from the current to the target maturity level
- **Work Plan Template:** An ordered set of actions based on the Recommended Practices

- under development

- **Resources and Skills Checklists:** Types of resources and skills needed
- **Implementation Checklist:** List of **Checkpoints** along the maturity path
- **Evaluation Template:** With reference to the **Work Plan**
 - What actions did we do, who did them, what worked well/could have been better, what resources did we use and what should we do in the next iteration
- **Action Plan Template:** Consolidation actions to adjust the new practices and put them in an stable process in the organisation for the long run.
