About The Session

The session will showcase good practices in how national governments, local authorities (e.g. cities) and communities, and other stakeholders successfully contextualized and ensured the uptake of gender-responsive standards in the economic, social and environmental spheres, with a view to contributing to the implementation of the 2030 Agenda for Sustainable Development. Participants will share their experience in ensuring women's equitable participation and leadership in decision-making at all levels.

The session is co-organized by the United Nations Economic Commission for Europe (UNECE), and UN Women Regional Office for Europe and Central Asia, with the support of the Mission of the Federal Republic of Germany in Geneva.

Note: As the Coronavirus COVID-19 is a growing concern internationally, this session – previously intended to be a Side Event to the Regional Forum on Sustainable Development – is now being convened online.

Background

Standards can support the uptake of resource-saving products and technologies, assist organizations in reporting on their commitments, and integrate an inclusive decision-making process, which empowers all stakeholders. They can help scale-up technological innovation and are at the very basis of increased competitiveness and economic progress: the full potential of standardization for the realization of the Sustainable Development Goals (SDGs) is neither fully understood nor harnessed.

In 2016, UNECE and its Working Party on Regulatory Cooperation and Standardization Policies (WP.6) launched the Gender-Responsive Standards Initiative as part of the activities on "Standards for SDGs". The initiative aims to strengthen the use of standards and technical regulations as powerful tools to attain SDG 5 (Achieve gender equality and empower all women and girls), integrate a gender lens in the development of both standards and technical regulations, as well as elaborate gender indicators and criteria that could be used in standards development.

OBJECTIVES:

- · Highlight the contribution of consensus-based standards to the implementation of Agenda 2030 and specifically SDG 5
- Share best practice in developing and implementing gender responsive standards and tracking progress on the contribution of Standards to the SDGs
- Spearhead the uptake of resource-saving products and technologies that are gender-responsive by design, by engaging with national, regional and international standards bodies
- · Identify bottlenecks and opportunities for women's full and effective participation in decision-making and for policy-makers uptake of international, regional and national standards.


PARTICIPANTS
