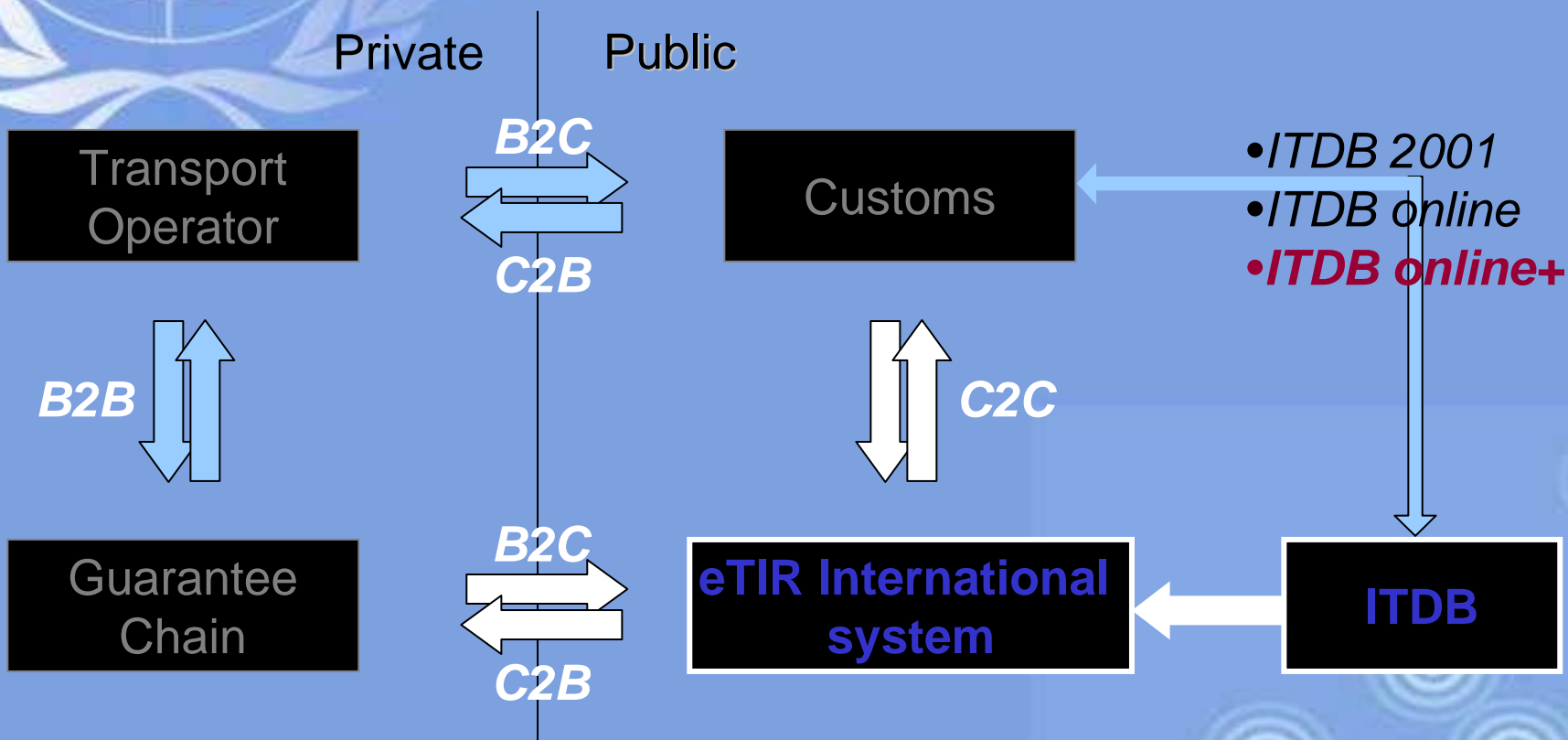

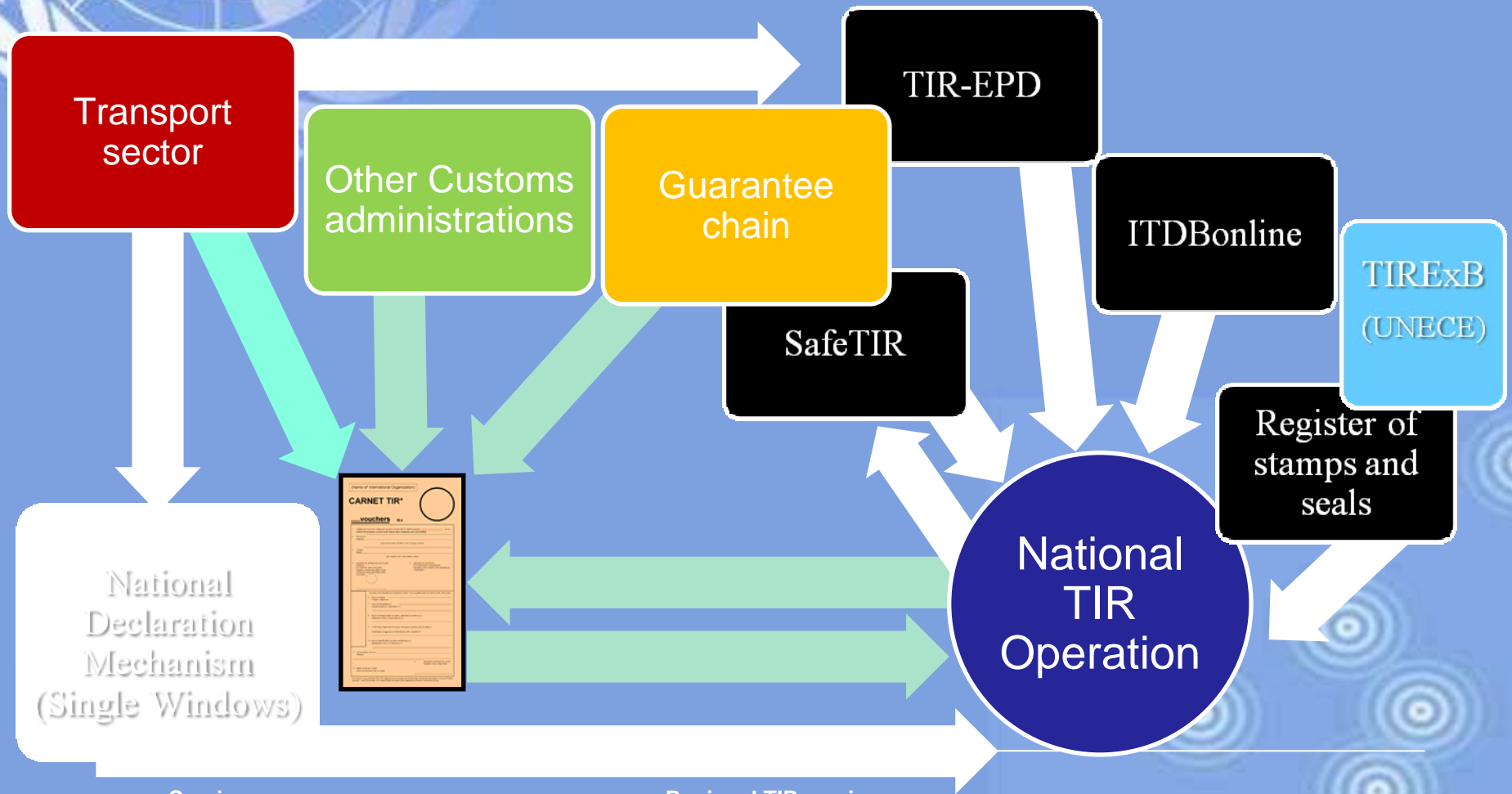

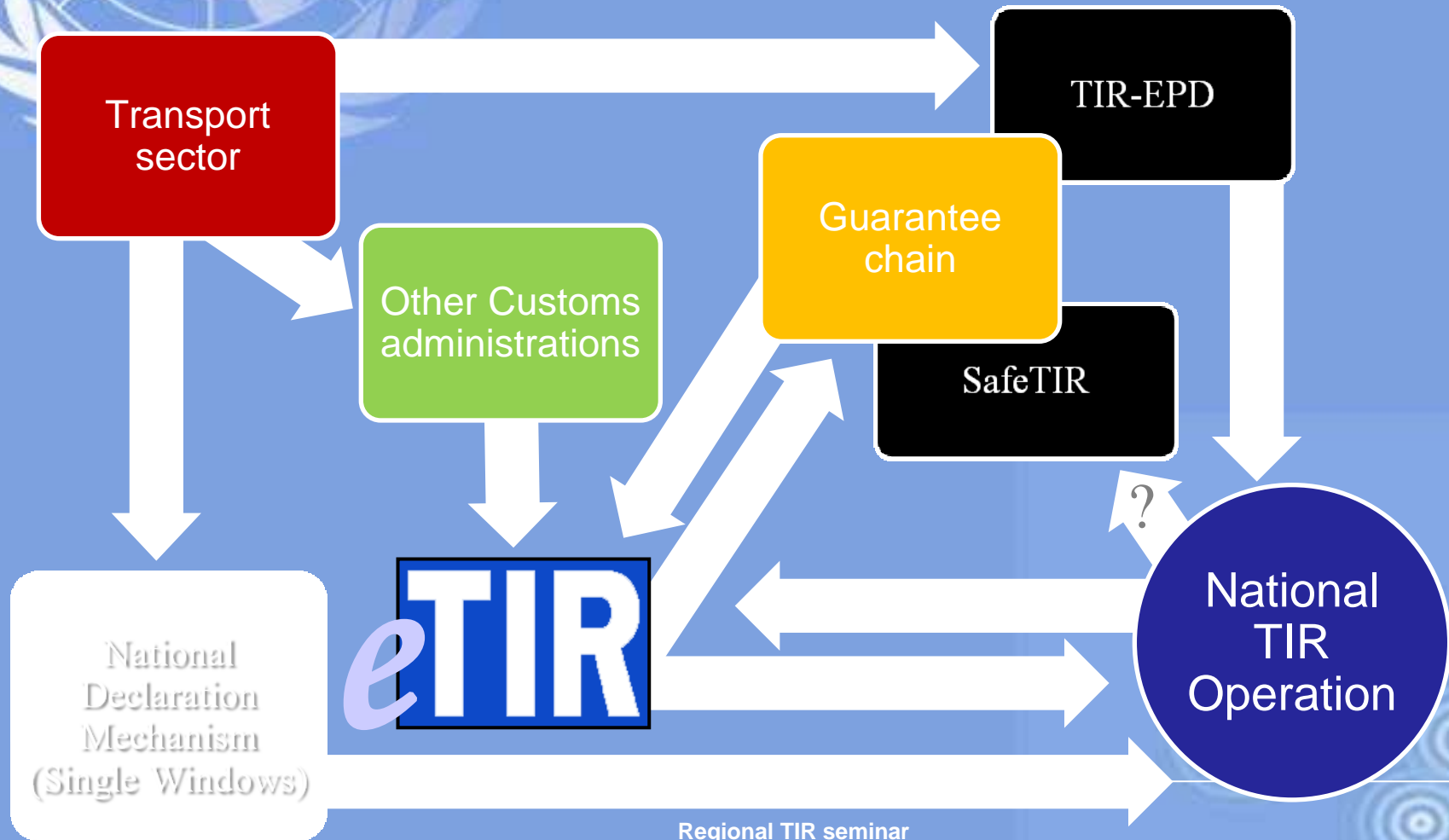
eTIR system

eTIR conclusions

- Major opportunities for all stakeholders
 - Increased security
 - Reduced administrative burden
 - Faster circulation of information
- Upcoming challenges
 - Finalize the Reference Model (conceptual)
 - Revise the TIR Convention (legal)
 - Develop the required systems (technical)

Overall requirement: full participation of all Contracting Parties in the technical (GE.1) and legal preparations (WP.30)

RECENT AMENDMENT PROPOSALS

- **Proposals to change maximum guarantee amount from US\$ 50,000 to €60,000 (not accepted)**
- **Proposals to amend various provisions of the Convention, in particular Articles 1, 8, 10 and 11 and Annex 6 (adopted)**
- **Proposals to amend Annex 9, Part I (adopted)**
- **Proposals to amend Annex 9, Part III (under consideration)**
