# 1. Adoption of the agenda

# 3. Information on the results of the meetings of the bureau

TRADE/WP.7/GE.6/2005/3 (Report Dublin) TRADE/WP.7/GE.6/2005/4 (Report Grand Forks)

These documents contain summaries of the extended bureau meetings held in Dublin, Ireland (5 to 7 July 2004) and Grand Forks, United States (4-6 October 2004). The report from the Grand Forks meeting contains many of the proposals for amendments to the UNECE standard and will be referred to under different agenda items.

# 4. Review of the UNECE Standard for Seed Potatoes

# (a) Netted scab

TRADE/WP.7/GE.6/2005/4, Item 8

In discussions of the list of pests and diseases and the assessment key it was found that there are different kinds of scab which are not distinguished in the standard (netted scab caused by Streptomices reticuliscabies). The proposal aims at clarifying this issue in the standard.

# (b) **Proposal for destination tolerances**

TRADE/WP.7/GE.6/2005/4, Item 1 TRADE/WP.7/GE.6/2005/5 (United Kingdom, United States, Netherlands)

The UNECE Seed Potato Standard defines quality tolerances at the export control point. However, there is a perception by the importing country that these are the quality standards to be applied at the point of import. This expectation is achievable for most of the diseases and defects listed in Annex III as they do

not develop during storage. However, a number of potato pathogens cause diseases which can progress during storage and, hence, during shipment, so that there is a risk that a tolerance may not be met at the point of import even although the tolerance was met at the point of export. The paper 2005/5 provided the background for the discussions and proposal contained in 2005/4.

# (c) Definition of leaf roll

TRADE/WP.7/GE.6/2005/4, Item 7

To complete the work on ensuring the consistency of definitions in the standard, a definition for leaf roll was developed.

# (d) Further development of Annex VIII: Images for common scab/ netted scab

TRADE/WP.7/GE.6/2005/4, Item 9 and Annex 1 TRADE/WP.7/GE.6/2005/6 (Germany)

New images for common scab were developed to replace the existing ones (see 2005/4). New images for netted scab will be proposed by Germany.

# (e) Interpretation of the size band

TRADE/WP.7/GE.6/2005/4, Item 2

At the last session it was found that the size band could be interpreted in different ways. The bureau meeting suggests a harmonized interpretation to be endorsed by the Specialized Section.

# (f) Inclusion of tomato spotted wilt virus and potato rot nematode

TRADE/WP.7/GE.6/2005/4, Item 11, 12, 20 TRADE/WP.7/GE.6/2005/7 (United Kingdom)

When reviewing the list of pests and diseases it had been found that these were agents included in other regulations but not in the UNECE standard. The bureau proposes to include the potato rot nematode in the standard. The United Kingdom will prepare a background paper on tomato spotted wilt virus.

# (g) Provisions concerning presentation

TRADE/WP.7/GE.6/2005/4, Item 4

The bureau proposes to update the current rules concerning presentation.

# (h) Homogeneity/size of the lot

TRADE/WP.7/GE.6/2005/4, Item 5 TRADE/WP.7/GE.6/2005/4, Item 18

Homogeneity is considered as an important value by customers and more related to quality than to presentation. It is proposed to move the requirement to provisions concerning quality and to rename the section on presentation. Further work will concentrate on how to ensure homogeneity.

# (i) Visusal inspection versus testing

TRADE/WP.7/GE.6/2005/4, Item 14

It is proposed to include a description of the methodology for conformity checks which can be either a viual examination or testing. The definition for testing was updated.

# (j) Improvement of annex IX (sampling)

TRADE/WP.7/GE.6/2005/4, Item 19 TRADE/WP.7/GE.6/2005/8 (Netherlands)

It is suggested to clarify practical use of annex IX on sampling and to add 0,5 % and 2 % in the table of tolerances, considering that these tolerance are now part of the standard for virus. An exchange of practices of taking samples for tuber inspection will take place at next extended Bureau meeting.

# (k) Proposal to rename the term "National Designated Authority" to "Designated Authority"

The delegation of the United States suggests this change because in their country seed potato certification is under state authority.

# 5. Recommended best handling practices

TRADE/WP.7/GE.6/2005/4, Item 17

Canada, that previously suggested the item, is no longer interested in discussing it. The item will be deleted from the agenda.

# 6. The concept of LMO's in the Standard

The discussion concerning living modified organisms was continued in the bureau and the porposal made at the last session by the Chairman was amended.

A prototype training course was developed in the bureau meetings. The Specialized Section is invited to discuss how to offer this training course to countries and how to ensure its financing.
