# PRESENTATION BY OECD AT THE FIFTY-SIXTH SESSION OF THE WORKING PARTY ON STANDARDIZATION OF PERISHABLE PRODUCE AND QUALITY DEVELOPMENT

## A. <u>Programme of work of the OECD Scheme for the Application</u> of International Standards for Fruit and Vegetables

At its fifty-ninth session, held on 13-15 May 2000, the Plenary Meeting of the Scheme adopted its programme of work. The programme includes two principal areas of work:

#### I. Quality standards and their interpretation

A decision was taken to prepare explanatory brochures on the standards for apples and pears, citrus fruits, plums, beans, tomatoes, strawberries, table grapes and cucumbers.

#### II. Quality assurance and quality control

#### B. Publications

The Scheme's most recent publications are explanatory brochures on the standards for carrots and broccoli and the colour gauge for cauliflower. An explanatory brochure on the standard for asparagus is due to be published by the end of the year. They can be purchased in hard copy or as electronic files.

#### C. <u>Promotion of the establishment of one single international</u> <u>grade-standard-setting body</u>

The Plenary Meeting mandated the Chairperson and secretariat of the Scheme to contact ECE and the Food and Agriculture Organization (FAO)/World Health Organization (WHO) informally with a view to obtaining assurances from ECE and FAO/WHO that they will take note of the following points and undertake to:

- (i) recognize the duplication of effort represented by the resources allocated by the three organizations currently involved in grade standard-setting;
- (ii) cooperate to establish a common approach aimed at limiting, to the extent possible, duplication of work in terms of resource allocation.

#### D. Countries requesting observer status in the Scheme

Following its application and the recommendations of the latest session of the Plenary Meeting, Bulgaria was granted ad hoc observer status in the Scheme until the next session of the Plenary Meeting.
