The UN Economic Commission for Europe, the Ministry of Economic Development and Trade, the Federal Customs Service and the Chamber of Commerce and Industry of the Russian Federation are organizing this Workshop on Trade Facilitation in the Russian Federation with the **objective** to: (1) review the status of market reforms and needs for trade facilitation in the Russian Federation; (2) explore the possibility to establish an organizational basis for trade facilitation implementation through public-private partnership; (3) define concrete projects, for example, the creation of "Single Window" for submission of trade information, or aligning trade and transport documents and electronic data exchange with international standards.

Such a workshop is timely for the Russian Federation because:

- (1) At present, WTO is incorporating trade facilitation into the core agenda of the multilateral trade negotiations, and the participation of Russia in this discussion will be important for the future;
- (2) Trade facilitation issues have a significant place in the current stage of integration of Russia in the global market. For instance, the project for the modernization of the Russian customs service, carried out together with the World Bank, already contains a call for elaborating a trade facilitation programme in the country. Trade facilitation plays a key role in attracting foreign investment and export promotion;
- (3) Russia's use of international standards for the facilitation of trade procedures is very important for the establishment of a common market among the countries of the Eurasian Economic Community (EurAsEC) and other regional initiatives, for the harmonization of procedures and the exchange of documents and data among the CIS countries, but also in transactions with Russia's foreign trading partners, who introduce automated business processes. As an example, the Workshop may discuss the construction of the frontier between Kazakhstan and the Russian Federation. Relevant donors, international organizations and representatives of the business community have been invited to the workshop. Trade facilitation issues in the relations between Russia and the European Union and between Russia and the Asian economies will be subjects of the discussions.
- (4) Trade facilitation also helps develop small and medium-sized enterprises, and the establishment of a stable middle class is a key issue in the development of a market economy in Russia;
- (5) The Government of Moscow, the Chamber of Commerce of Moscow, UNDP and others have demonstrated interest in working with UNECE on trade facilitation projects and an organizational structure for trade facilitation implementation.

UNECE, through UN/CEFACT, has forty years of experience in the area of simplification, harmonization and automation of trade procedures. As the UN body responsible for the development of standards in this area, UN/CEFACT has developed over 30 Recommendations on trade facilitation. The Ministry of Economic Development and Trade represents the Russian Federation in UN/CEFACT. The Customs service of the Russian Federation is a key partner in the organization of the workshop, as important trade facilitation issues are in the remit of Customs. In many countries, the private sector and chambers of commerce and industry play an essential role in trade facilitation through the national organizations for trade facilitation (PRO Committees), which often constitute an integral part of the chamber. One of the issues in the discussions will be the existing options for creating an organizational basis for trade facilitation in the Russian Federation.

The Workshop will introduce the participants to opportunities and challenges of trade facilitation from the point of view of Supply Chain management. Some new concepts, such as the Single Window, and the specifics of trade facilitation in selected sectors will be presented. With security becoming an imperative in international trade, this Workshop will also address the impact of Supply Chain security on trade facilitation and supply chain management, for the implementation of Supply Chain security offers significant advantages for trade security and commercial benefits.
