### **International TIR Data Bank (ITDB)**

#### **Note by the TIR secretariat**

1. In line with the established practice, the Committee may wish to be informed of the status of the transmission of legally required documentation. The following table shows the status of the transmission of data to the ITDB in compliance with Annex 9, Part II, paragraphs 4 and 5, as well as the status of transmission of statutory information concerning insurance certificates, which is required at the beginning of each calendar year.
2. The ITDB contains at present information on more than 34,000 persons/companies (more than 35,000 persons/companies last year) authorized by national Customs authorities to utilize the TIR procedure and more than 37,000 persons/companies who have been withdrawn from the TIR system or have decided to end their TIR activities. It also contains information on persons excluded from the TIR procedure in accordance with Article 38 of the Convention.
3. The information contained in the ITDB can be consulted and amended on-line, using the ITDB online+ website, by Customs TIR Focal Points and by other Customs officials appointed by the national TIR Customs Focal Point and subsequently authorized by the TIR secretariat. National associations may also collaborate with Customs authorities to request modifications in the ITDB using the ITDB online+ website. The modifications requests will be validated by the competent Customs authorities. Authorization for national association's users should be requested through the corresponding TIR Focal Point.
4. Further to the entry into force of amendments to Annex 6, Explanatory Notes 9.II.4 and 9.II.5, the TIR secretariat takes into account in the attached table that many Contracting Parties perform their data transmission by means of the ITDB online+ website.
