

MULTILATERAL AGREEMENT M230

Under paragraph 1.5.1 of Annex A of ADR concerning the carriage of UN 2990 and UN 3072 (life-saving appliances, self-inflating and not self-inflating)

(1) By derogation from the provisions of Table A: Dangerous Goods List 3.2.1 of ADR, the entries for UN 2990 LIFE-SAVING APPLIANCES, SELF-INFLATING and UN 3072 LIFE-SAVING APPLIANCES NOT SELF-INFLATING are not subject to the requirements of ADR if packed in strong rigid outer packagings with a total maximum gross mass of 40kg, containing no dangerous goods other than Class 2, classification codes 1A or 2A in receptacles with a capacity not exceeding 120ml, installed solely for the purpose of the activation of the appliance.

(2) This agreement shall be valid until 31 December 2012 for the carriage on the territories of those ADR Contracting Parties signatory to this agreement. If it is revoked before then by one of the signatories, it shall remain valid until the above mentioned date only for carriage on the territories of those ADR Contracting Parties signatory to this agreement which have not revoked it.
