

## ROMANIA

### **Competent authorities for the application of the European Agreement concerning the International Carriage of Dangerous Goods by Road (ADR), derogations, restrictions and serious accidents**

#### 1. The temporary bilateral or multilateral agreements (derogations)

Romania has not concluded (according to paragraph 1.5.1.1 of Annex A) bilateral or multilateral agreements with the other Contracting Parties to ADR having the content derogatory to the provisions of ADR.

2. The names and address of authorities and bodies designated by the Romanian Government which are competent in accordance with national law to implement ADR.

3. The additional provisions (restrictions) within the scope of 1.9.3 (a) and (d), if any, applying on the Romanian territory

The restrictions concerning the traffic of vehicles carrying dangerous goods in Romania are governed by:

- the Government Decision no. 890 of 03/06/2004, published in the Official Journal, Part I, no. 544 of 17/06/2004, for the amendment and the completion of the Regulation for applying the Government Expeditious Ordinance no. 195/2002 regarding the traffic on public roads, approved by the Government Decision no. 85/2003 and
- the Common Order no. 2059/2004 of the Ministry of Transport, Construction and Tourism and of the Ministry of Administration and Interior for the approval of the Instructions regarding the notice foreseen in art. 220<sup>1</sup> paragraph (3) of the Regulation for applying the Government Expeditious Ordinance no. 195/2002 regarding the traffic on public roads, approved by the Government Decision no. 85/2003, as amended and completed.

4. Report on serious accidents or incidents taking place during the carriage of dangerous goods on the Romanian territory, in accordance with the obligations resulting from paragraphs 1.5.1.1, 1.8.4, 1.8.5.2 and 1.9.4 of Annex A of ADR
