1/ The thirty-ninth session was initially scheduled to be held from 24 (afternoon) to 27 (morning only) February 2004. However, during its last session (TRANS/WP.29/GRB/36, para. 18), GRB decided to start the session on Tuesday morning, 24 February 2004 (09.30h), and completing it Thursday afternoon, 26 February 2004 (17.30h). These modifications to the agenda were confirmed by WP.29 at its one-hundred-and-thirty-first session (TRANS/WP.29/953, para. 10).

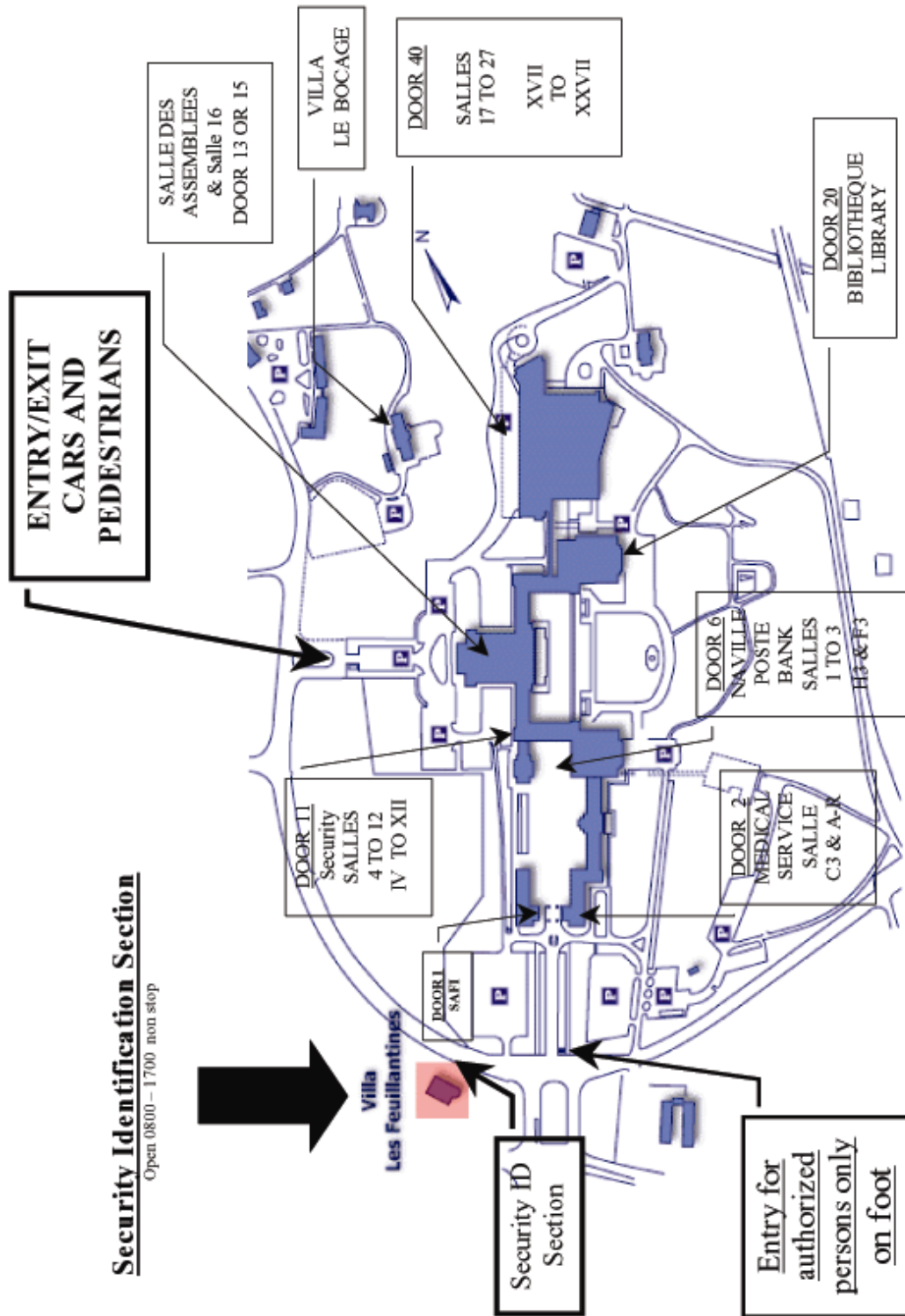
