MISCELLANEOUS PROPOSALS FOR AMENDMENTS TO THE MODEL REGULATIONS ON THE TRANSPORT OF DANGEROUS GOODS

Miscellaneous - Editorial

1. DINITRO-o-CRESOLATE

1843 AMMONIUM DINITRO-o-CRESOLATE, SOLID
3424 AMMONIUM DINITRO-o-CRESOLATE, SOLUTION
are classified in Division 6.1

1348 SODIUM DINITRO-o-CRESOLATE, WETTED with not less than 15% water, by mass
is classified in Division 4.1 with subsidiary risk 6.1

A **subsidiary risk 6.1** should then be allocated also to:

0234 SODIUM DINITRO-o-CRESOLATE, dry or wetted with less than 15% water, by mass
(which is classified 1.3C) and

3369 SODIUM DINITRO-o-CRESOLATE, WETTED, with not less than 10% water by mass
(which is classified 4.1)

2. TRINITROPHENOL

Taking care of the existing entries:

0154 TRINITROPHENOL (PICRIC ACID), dry or wetted with less than 30% water, by mass

1344 TRINITROPHENOL, WETTED with not less than 30% water, by mass

3364 TRINITROPHENOL (PICRIC ACID), WETTED, with not less than 10% water by mass

it is proposed to **add** (PICRIC ACID) to UN 1344

3. TRINITROTOLUENE

Taking care of the existing entries:

0209 TRINITROTOLUENE (TNT), dry or wetted with less than 30% water, by mass

1356 TRINITROTOLUENE, WETTED with not less than 30% water, by mass

3366 TRINITROTOLUENE (TNT), WETTED, with not less than 10% water by mass

it is proposed to **add** (TNT) to UN 1356

4. PENTAERYTHRITE TETRANITRATE

Taking care of the existing entries:

0150 PENTAERYTHRITE TETRANITRATE (PENTAERYTHRITOL TETRANITRATE; PETN), WETTED with not less than 25% water, by mass, or PENTAERYTHRITE TETRANITRATE (PENTAERYTHRITOL TETRANITRATE; PETN), DESENSITIZED with not less than 15% phlegmatizer, by mass

0411 PENTAERYTHRITE TETRANITRATE (PENTAERYTHRITOL TETRANITRATE; PETN) with not less than 7% wax, by mass

3344 PENTAERYTHRITE TETRANITRATE MIXTURE, DESENSITIZED, SOLID, N.O.S. with more than 10% but not more than 20% PETN, by mass

it is proposed to **add** "PENTAERYTHRITOL TETRANITRATE" and "PETN" to UN 3344
