## Explanatory notes

### I. General

#### Status and membership

1. The Committee is a subsidiary body of the Economic and Social Council, and was previously known as the “Committee of Experts on the Transport of Dangerous Goods”. It was reconfigured by the Economic and Social Council’s resolution 1999/65 of 26 October 1999 as the Committee of Experts on the Transport of Dangerous Goods and on the Globally Harmonized System of Classification and Labelling of Chemicals, with two sub-committees, the Sub-Committee of Experts on the Transport of Dangerous Goods (TDG Sub-Committee) and the Sub-Committee of Experts on the Globally Harmonized System of Classification and Labelling of Chemicals (GHS Sub-Committee) (refer also to document ST/SG/AC.10/C.4/2001/7). The first session of the Committee was held in Geneva from 11 to 12 December 2002, and the report was circulated as document ST/SG/AC.10/29 and Add. 1-2. The second session was held in Geneva on 10 December 2004, and the report was circulated as document ST/SG/AC.10/32 and –Add. 1-3 and –Add.3/Corr.1. The third session was held in Geneva on 15 December 2006 and the report was circulated as document ST/SG/AC.10/34 and Add. 1–3, Add.1/Corr.1, Add.2/Corr.1 and Add.3/Corr.1. The fourth session was held in Geneva on 12 December 2008 and the report was circulated as document ST/SG/AC.10/36 and -36/Corr.1, and Add. 1-3, Add.1/Corr.1 to 3 and Add.2/Corr.1.

2. Pursuant to the Economic and Social Council’s decisions 2001/201B, 2002/201C, 2003/201D, 2005/201C, 2008/201C, 2009/201C and 2010/201B the membership of the Committee is 39, as follows:

#### **Interpretation**

8. Interpretation during the session will be provided in Chinese, English, French, Russian and Spanish.

#### **Rules of procedures**

9. In accordance with Rule 27 of the Rules of Procedure of the Economic and Social Council, Chapters VI and VIII to XII of the Rules of Procedure of the Economic and Social Council apply to the proceedings of the Committee and of its sub-committees (refer also to documents ST/SG/AC.10/C.4/2001/1 and ST/SG/AC.10/C.4/2001/6).

#### **Mandate**

10. In accordance with resolution 1999/65, the mandate of the Committee is to deal with strategic issues rather than technical issues. It is not envisaged that it would review, change or revisit technical recommendations of the sub-committees.

11. Its main functions are:

- (a) To approve the work programmes of the sub-committees in the light of available resources;
- (b) To coordinate strategic and policy directions in areas of shared interests and overlap;
- (c) To give formal endorsement to the recommendations of the sub-committees and provide the mechanism for channelling them to the Economic and Social Council;
- (d) Facilitate and coordinate the smooth running of the sub-committees.

#### **Timetable**

12. The length of the session has been limited to half a day. It will be preceded by the thirty-eight session of the TDG Sub-Committee (29 November – 7 December 2010) (agenda: ST/SG/AC.10/C.3/75 and -/Add.1) and the twentieth session of the GHS Sub-Committee (7 (p.m) – 9 December 2010) (agenda: ST/SG/AC.10/C.4/39 and -/Add.1).

## **II. Adoption of the agenda (agenda item 1)**

13. In accordance with the established practice, the first item on the agenda is the adoption of the agenda.

## **III. Election of officers (agenda item 2)**

14. In accordance with the established practice, the Committee shall elect one President and one or several vice-presidents from among the representatives of its members.

#### **IV. Resolutions and decisions of the Economic and Social Council (agenda item 3)**

15. The resolutions and decisions of the Economic and Social Council of relevance to the work of the Committee during the biennium 2009-2010 are as follows:

- Resolution 2009/19 of 29 July 2009 (Work of the Committee) (see informal documents UN/SCETDG/34/INF.74 or UN/SCEGHS/16/INF.32).

#### **V. Work of the Sub-Committee of Experts on the Transport of Dangerous Goods during the biennium 2009-2010 (agenda item 4)**

16. The reports of the TDG Sub-Committee on its thirty-fifth, thirty-sixth and thirty-seventh sessions are contained in documents ST/SG/AC.10/C.3/70; ST/SG/AC.10/C.3/72; ST/SG/AC.10/C.3/74 and Add.1.

17. The list of draft amendments to the Recommendations on the Transport of Dangerous Goods, Model Regulations and Manual of Tests and Criteria adopted so far by the Sub-Committee has been consolidated in document ST/SG/AC.10/C.3/2010/50.

18. These draft amendments are still subject to a final reading at the Sub-Committee's thirty-eighth session (29 November – 7 December 2010) where additional amendment proposals should also be discussed. The report of the Sub-Committee on its thirty-eighth session will be made available to the Committee either in its final form or in the draft form prepared by the secretariat, as documents ST/SG/AC.10/C.3/2010/CRP.3 and addenda for the report proper and ST/SG/AC.10/C.3/2010/CRP.4 and addenda for changes to the consolidated list of draft amendments. The Committee may wish to endorse the draft amendments adopted by the Sub-Committee and any other recommendations made by it.

#### **VI. Work of the Sub-Committee of Experts on the Globally Harmonized System of Classification and Labelling of Chemicals during the biennium 2009-2010 (agenda item 5)**

19. The reports of the GHS Sub-Committee on its seventeenth, eighteenth and nineteenth sessions have been issued as documents ST/SG/AC.10/C.4/34, ST/SG/AC.10/C.4/36 and ST/SG/AC.10/C.4/38.

20. The report of the Sub-Committee on its twentieth session will be made available to the Committee either in its final form or under the draft form prepared by the secretariat (ST/SG/AC.10/C.4/2010/CRP.3 and addenda for the report proper and ST/SG/AC.10/C.4/2010/CRP.4 and addenda). The Committee may wish to endorse the draft amendments adopted by the Sub-Committee and any other recommendations made by it.

## **VII. Programme of work for the biennium 2011-2012 (agenda item 6)**

### (a) Programme of work and related proposals

The Committee should consider the proposals made by the TDG and the GHS Sub-Committees at their December 2010 sessions for their respective programmes of work, and approve them in the light of resources available for 2011-2012.

### (b) Calendar of meetings

The total number of meeting days allocated to the Committee and its sub-committees by the Economic and Social Council for a biennium is 38 days (i.e. 76 meetings of three-hour duration). On the basis of the experience for the biennium 2009-2010, the following dates have been provisionally scheduled by the secretariat for 2011-2012:

The Committee may wish to note that both sub-committees will have prepared their own contribution to the draft resolution to be submitted to the Economic and Social Council for adoption at its 2011 substantive session. The Committee should combine the two parts and adopt the draft resolution to be submitted to the Council.

22. At the time of writing, there is no issue under this agenda item.

## **X. Adoption of the report (agenda item 9)**

23. The Committee should adopt the report on its fifth session on the basis of a draft prepared by the secretariat.
