Annotations to the agenda

1. Adoption of the agenda

1. The Administrative Committee may wish to consider and adopt the agenda for its eleventh session drawn up by the secretariat and issued under the symbol ECE/ADN/23 and Add.1.

2. Status of the European Agreement concerning the International Carriage of Dangerous Goods by Inland Waterways (ADN)

2. The Administrative Committee will be informed about the status of the ADN and the number of Contracting Parties.

3. Matters relating to the implementation of ADN

(a) Recognition of classification societies

3. The Committee will be informed about the status of the request by the German subsidiary of Registro Italiano Navale (RINA) to be recognised as a recommended ADN Classification Society. Since the last session of the Committee, Switzerland has notified the

secretariat that it has recognised the classification societies Germanischer Lloyd, Bureau Veritas and Lloyd's Register of Shipping.

(b) Special authorizations, derogations and equivalents

4. The Administrative Committee may wish to approve the request from the Netherlands for the issuance of temporary derogations for *I-Tankers 1403* and *1404* for the use of liquefied natural gas as fuel if the proposed derogations have been approved by the CCNR (ECE/TRANS/WP.15/AC.2/46, paras. 9-11). The Government of the Netherlands has also requested that the ADN Administrative Committee consider granting temporary derogations for two further tank vessels, *Chemgas 851* and *Chemgas 852*, for the use of liquefied natural gas as fuel (see Informal document INF.2 issued for the twenty-third session of the Safety Committee).

(c) Miscellaneous notifications

5. The Administrative Committee may wish to refer to Informal document INF.1 issued at the last session of the Committee on the status of notifications to be made to the UNECE secretariat.

(d) Other matters

6. The Administrative Committee is invited to adopt the harmonized vessel checklists (ECE/TRANS/WP.15/AC.2/2013/14) and the decision contained in document ECE/ADN/2013/1. The Committee is invited to consider any other matters related to the implementation of the ADN.

4. Work of the Safety Committee

7. The Administrative Committee is expected to consider the work of the Safety Committee on its twenty-third session (26 to 30 August 2013) on the basis of its draft report.

5. Programme of work and calendar of meetings

8. The twelfth session of the ADN Administrative Committee is scheduled to take place on 31 January 2014.

6. Any other business

9. The Administrative Committee may wish to discuss any other issue raised in relation to its work and mandate.

7. Adoption of the report

10. The Administrative Committee may wish to adopt the report on its eleventh session on the basis of a draft prepared by the secretariat which will be sent to participants by email for approval after the session.
