2. Programme of Work

At the first session, the Group of Experts decided to include in its programme of work, the items (a) to (g) below, and agreed to discuss items (h) to (j) at this session. In addition, for items (a) to (g), as part of the remit of the responsible subgroup, the Group of Experts proposed the inclusion of deliverables, measurements, evaluation including sustainability, and the identification of gaps for the future strategy and action plan of the Group of Experts.

(a) A review and analysis of the economic costs of level crossing accidents based on data provided by countries

The Group of Experts will be updated on the progress of the work of the subgroup that is being led by Poland with assistance from the European Railway Agency (ERA).

(b) An evaluation and analysis of the safety performance of types of level crossings in UNECE member States and in selected non-UNECE member States such as Australia, India, New Zealand and South Africa

The Group of Experts will be updated on the progress of the work of the subgroup that is being led by Community Safety Partnerships Ltd with assistance from United Kingdom of Great Britain and Northern Ireland, France, Ireland and ERA.

(c) A summary of best practices including education

The Group of Experts will be updated on the progress of the work of the subgroup that is being led by Finland with assistance from India.

(d) A survey of prevailing national legislation and/or legal arrangements at level crossings

The Group of Experts will be updated on the progress of the work of the subgroup that is being initiated by the Instytut Kolejnictwa, Poland, with assistance of the secretariat.

(e) A survey of technology and technological solutions to improve safety at level crossings

The Group of Experts will be updated on the progress of the work of the subgroup that is being initiated by La Trobe University Centre for Technology Infusion, Australia, with the assistance of the secretariat.

(f) Identification of the key causes and possible solutions related to human factors contributing to unsafe conditions at level crossings

The Group of Experts will be updated on the progress of the work of the subgroup that is being initiated by Mr. Michael Cale, Cognito Ltd. and the German Aerospace Center.

(g) List of network contacts

This list would be made available on the website of the Group of Experts. The secretariat will provide an update on the progress of the list.

(h) Key factors contributing to unsafe conditions at level crossings

The proposed areas to be considered include infrastructure, national legislation, user behaviour, management, education and enforcement.

(k) Future strategic and operational research needs
