### **2. UNECE Inland Transport Committee and its subsidiary bodies**

The Working Party may wish to be informed about the results of the seventy-sixth session of the Inland Transport Committee (ITC) (25–27 February 2014), in particular about its decisions on the 2015 E-road and E-rail traffic censuses (ECE/TRANS/240, paras. 89–92), as well as of any other activities of its subsidiary bodies and the UNECE secretariat of interest to the Working Party.

### **3. Data collection, methodological development and harmonization of transport statistics**

#### **(a) Glossary for Transport Statistics**

The Working Party may wish to consider the draft definitions of energy types for road motor vehicles proposed in the document ECE/TRANS/WP.6/2014/1 as well as any other amendment or correction to be included in the fifth edition of the Glossary.

The Working Party invited the Intersecretariat Working Group on Transport Statistics (IWG) to consult with experts on inland navigation about the editorial amendments proposed in document ECE/TRANS/WP.6/2013/1.

The Working Party invited all member States to submit suggestions for improvements or/and additions to the Glossary.

#### **(b) Classification system for transport statistics**

The Working Party decided to establish a Task Force on classification with the following mandate: to maintain the conversion between NSTR and NST 2007 and other classifications, to propose where to classify new goods, to answer questions related to classification and to report to the next session of the Working Party (Informal document WP.6 No. 1 (2014)).

The Working Party may wish to exchange views on implementing NST 2007 in order to identify the best practices. Delegates are invited to inform the Working Party of their experiences on the use of NST 2007 at the present session.

**(c) Common questionnaire**

The Working Party may wish to be informed about the availability of data collected through the common questionnaire for transport statistics.

The Working Party decided to establish a Task Force with the mandate of streamlining the Common questionnaire.
