1. This document is submitted in line with cluster 5: Inland Waterway Transport, paragraph 5.1 of the programme of work 2014–2015 (ECE/TRANS/2014/23) adopted by the Inland Transport Committee on 27 February 2014.
2. The secretariat reminds that at its fifty-eighth session, the Working Party on Inland Water Transport (SC.3) adopted the division of Resolution No. 60 into two resolutions, Resolution No. 79, "International Standards for Electronic Ship Reporting in Inland Navigation" and Resolution No. 80, "International Standards for Notices to Skippers in Inland Navigation" (ECE/TRANS/SC.3/197, para. 46).
3. Given that Resolution No. 57 (ECE/TRANS/SC.3/165/Rev.1) contains several references to former Resolution No. 60, the secretariat suggests the following amendments to the Annex to Resolution No. 57, in order to update these references.

5. *Renumber* existing paragraph 1.5 (j) in paragraph 1.5 (i)

6. *Add paragraphs 1.5 (j) and 1.5 (k) as follows*

    - (k) UNECE Resolution No. 80 on International Standards for Notices to Skippers in Inland Navigation (ECE/TRANS/SC.3/199).
  7. *Amend paragraph 4.3.6 (d) as follows*
