## 2. Meeting objectives and overall project status

The UNDA project 1213AA -Strengthening the capacities of developing countries and countries with economies in transition to facilitate legitimate border crossing, regional cooperation and integration- is a global project involving the five RC, i.e. the Economic Commission for Europe (UNECE), the Economic and Social Commission for Western Asia (ESCWA), the Economic Commission for Africa (ECA), the Economic and Social Commission for Asia and the Pacific (ESCAP) and the Economic Commission for and Latin America and the Caribbean (ECLAC). Each RC, is responsible for a sub-regional project aimed at increasing the use of Customs to Customs (C2C) electronic data exchange to further secure and accelerate international transport of goods.

This first session of the Expert Group is aimed at coordinating the five sub-regional projects and at sharing information on topics relevant to the project, e.g. international standards, relevant expert for capacity building, etc. Furthermore, for each regional case, the Expert Group will recommend one of the two possible options for the second phase of the project: (a) provision of technical assistance to national or regional customs authorities to interconnect customs IT systems through a C2C exchange platform or (b) development of an Action Plan setting out the steps needed to enable the exchange of transit information via a C2C platform.

### 5. Recommendations and conclusions

On the basis of available "gap" analyses, which are aimed at assessing the legal and technical needs of candidate countries to enable or extend C2C electronic exchange of transit information, and of the experience of the experts present, the Expert Group will identify pilot countries which would most benefit from the project resources. The Expert Group will also determine for each RC if the resources available for the project would be best used for technical assistance aimed at implementing C2C electronic data exchange, for the development of an action plan and/or for capacity building.

The Expert Group may also wish to exchange view on the existing relevant standards and international agreements in the field of Customs and consider which should be promoted in the framework of this project.

## 6. Next steps

The Expert Group may wish to review the remaining project activities and their schedule, as proposed in Informal document UNDA1213AA/No. 7 (2014), and start considering the best venue and timing for the second Expert Group meeting, which will revise the project outcome, as well as the Seminar that will be organized back to back.

UNECE secretariat will prepare a summary report of the session and circulate it among all participants within 2 weeks after the meeting.
