

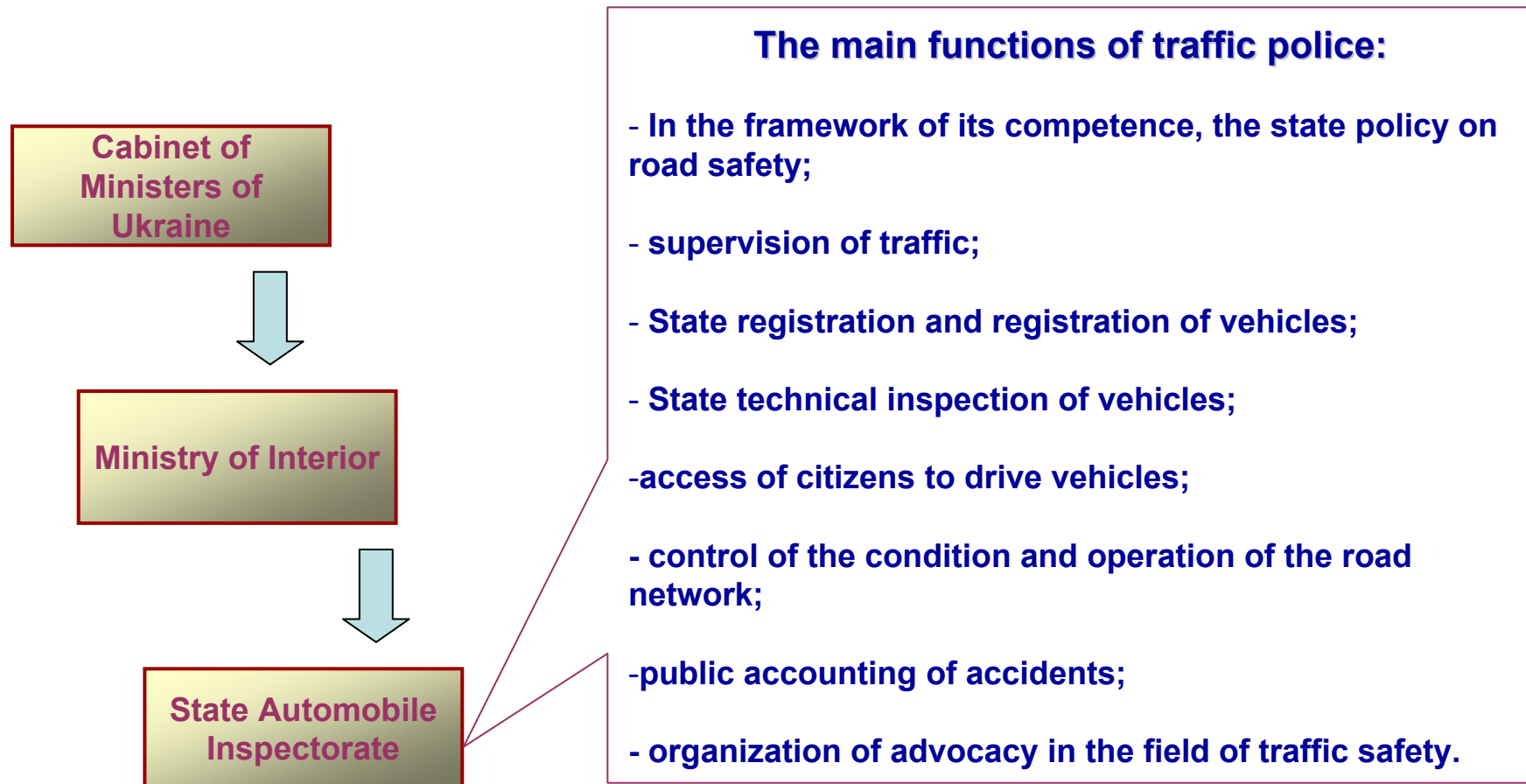


ROAD SAFETY IN UKRAINE

State Automobile Inspectorate Ministry of Internal Affairs of Ukraine in the system of public authorities.

Law of Ukraine "On Road Traffic"

Article 2. "Public administration in the field of road safety and its security is carried out at the Cabinet of Ministers of Ukraine, specifically authorized by the central executive authorities, local executive authorities, local self-government. Road safety rests with the State Automobile Inspectorate, which is part of the Ministry of Internal Affairs of Ukraine. "

The legislative changes in Ukraine 1991 - 2008

1991 – increase in the size of penalties;

increase the period of disqualification driving (minimum - 1 year, maximum - 2 years);

direction of the driver's knowledge of traffic rules for examination in the case of systematic violation of traffic rules (three or more violations per year);

imposition of penalties, including disqualification from managing traffic police;

detention of the driver's license or vehicle offender violator before the execution of punishment imposed.

2001 – transfer of competence for all types of violations under the jurisdiction of the courts in fact their unwillingness to consider the materials;








depriving workers of the state automobile inspection law imposing penalties for violations of traffic rules

destruction mechanism for enforcement of sentences imposed.

2008 – increased responsibility in the field of road safety.

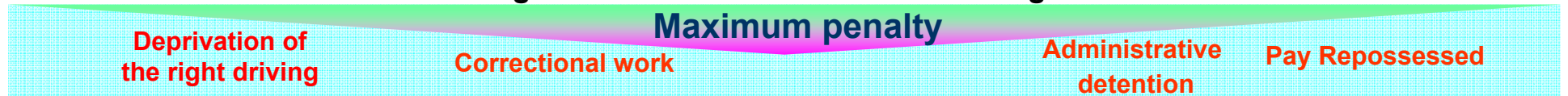
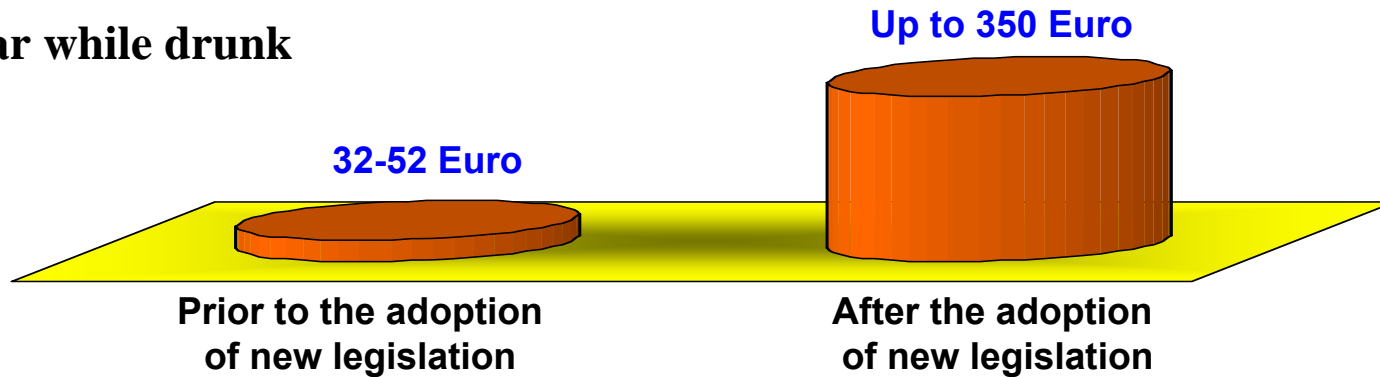
NEW LEGISLATION OF UKRAINE IN THE FIELD OF ROAD SAFETY

KEY POINTS:

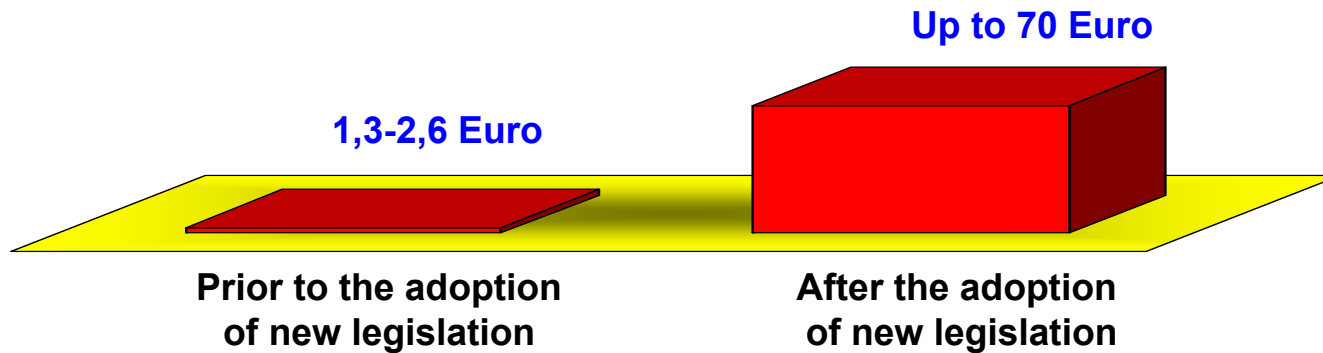
-  **Increased responsibility and fines depending on the severity of the offense (in 10 - 20 times), the introduction of new types of penalties (administrative arrest, public works)**
-  **Return of law imposing penalties by state car inspection revealed violations (except in cases of deprivation of rights management)**
-  **Legislative support the introduction of technical means auto-commit violations of traffic regulations. This establishes the liability of vehicle owners in those cases where it is impossible to identify who drives a vehicle at the time of the violation.**
-  **Recreating the mechanism of punishment for an offense in road safety (arrest a driver license before the court decision, the detention of the vehicle in fines defaulters, monitoring of a fine for inspection, registration; confiscation of the vehicle from malicious defaulters)**
-  **Improvement of driver training**
-  **Increased accountability of ministries and departments in the field of road safety.**
-  **The redistribution of funds from the payment of fines between the state and local budgets (50% to 50%), which then can be directed to activities on road safety**

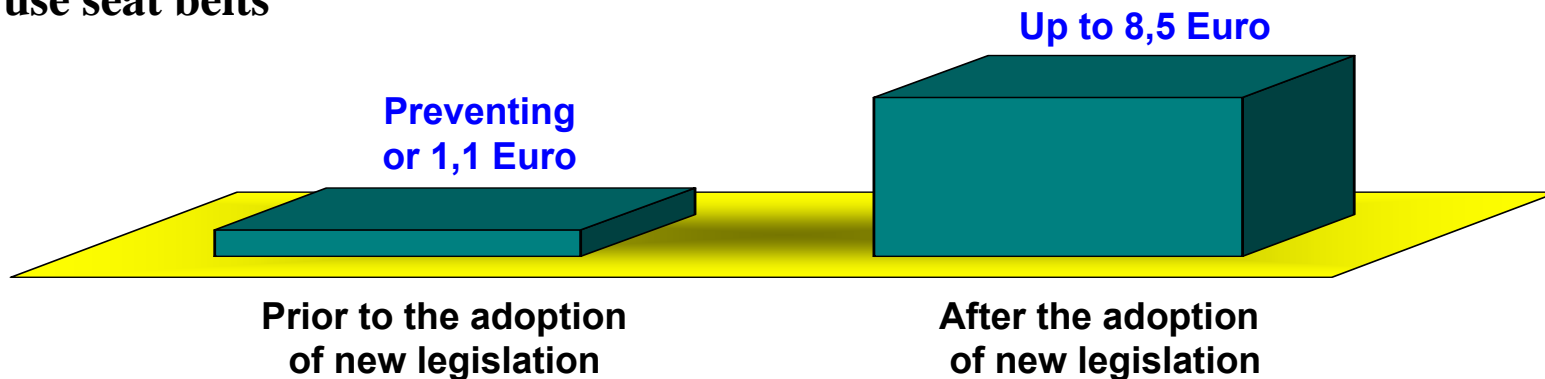

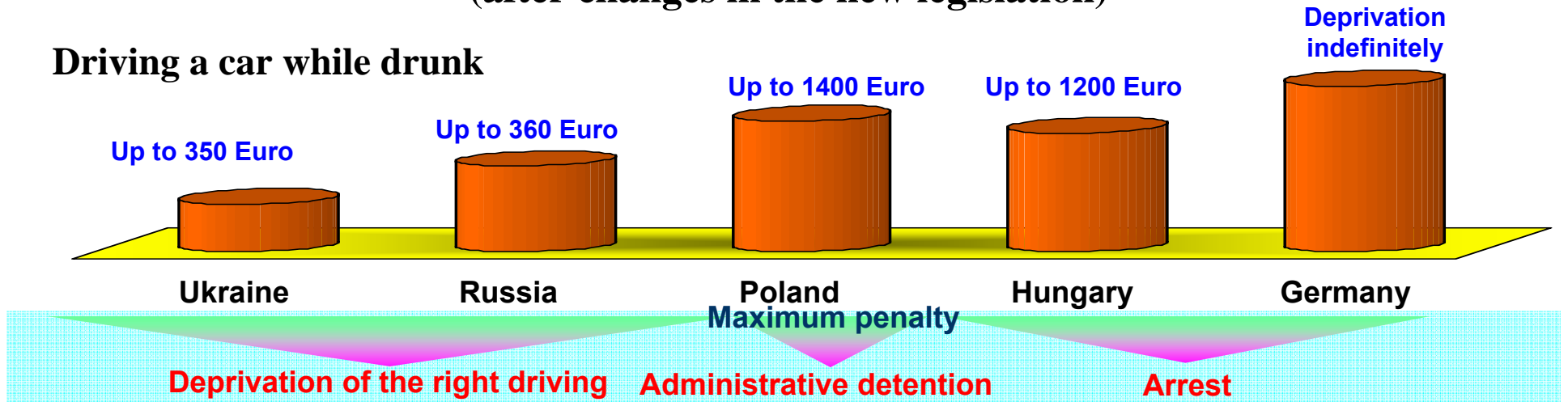

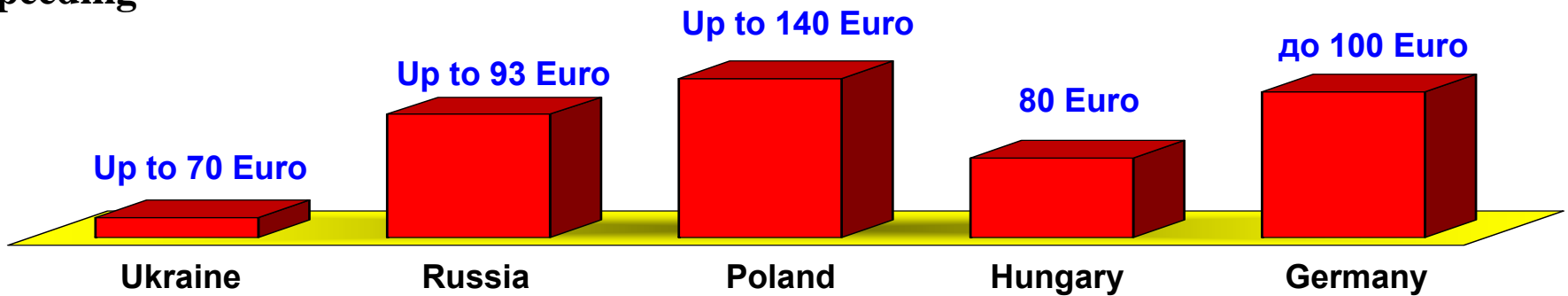


Penalties for violation of rules (after changes in the new legislation)

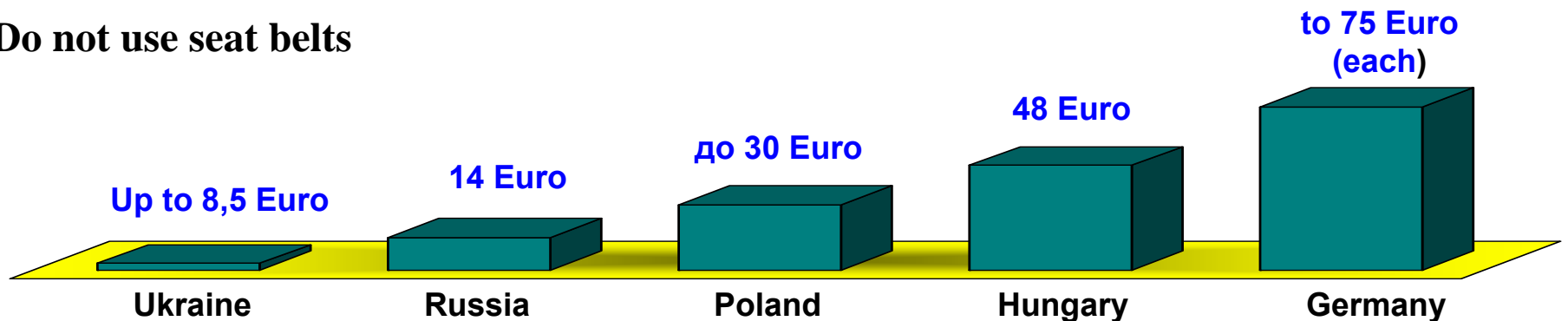

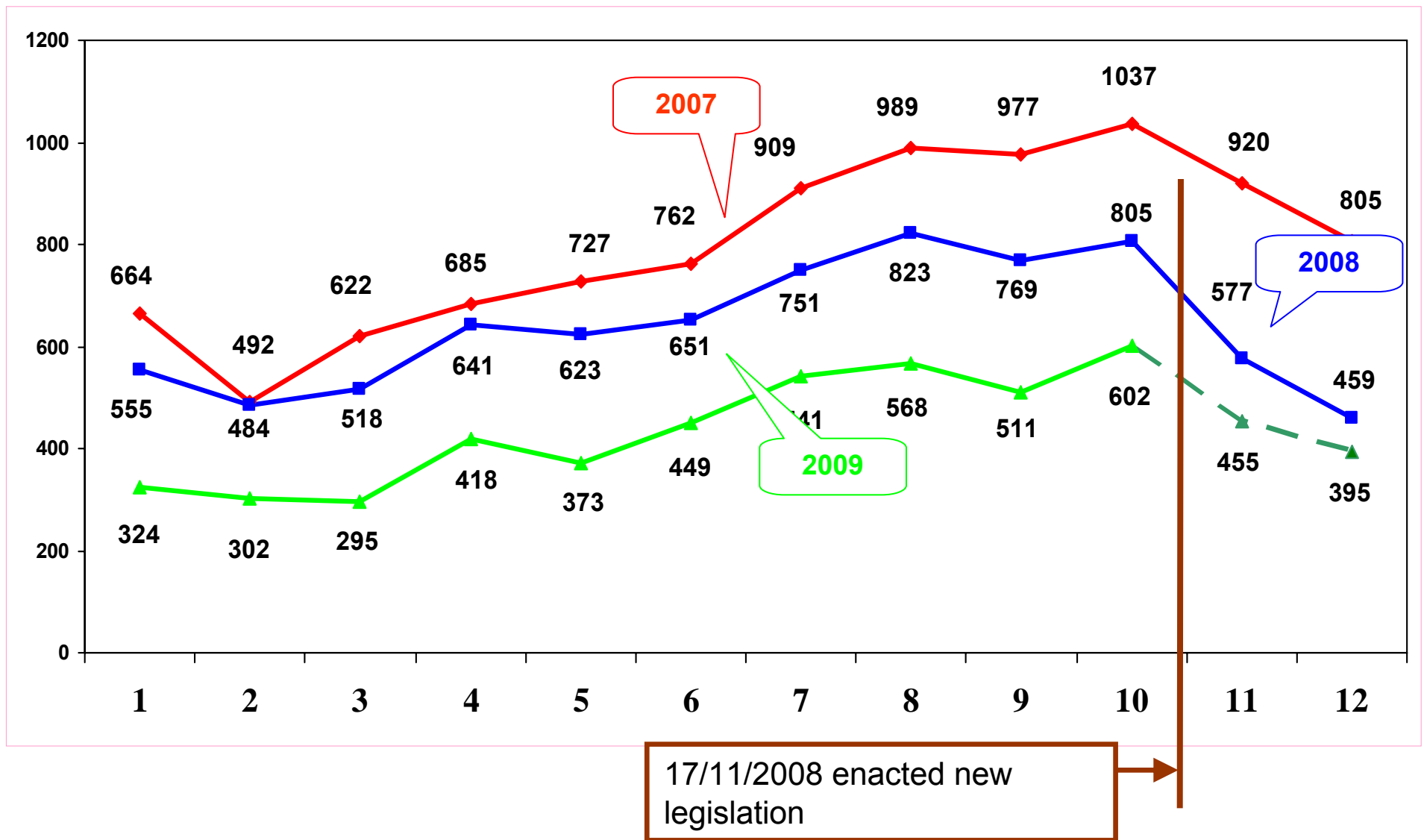

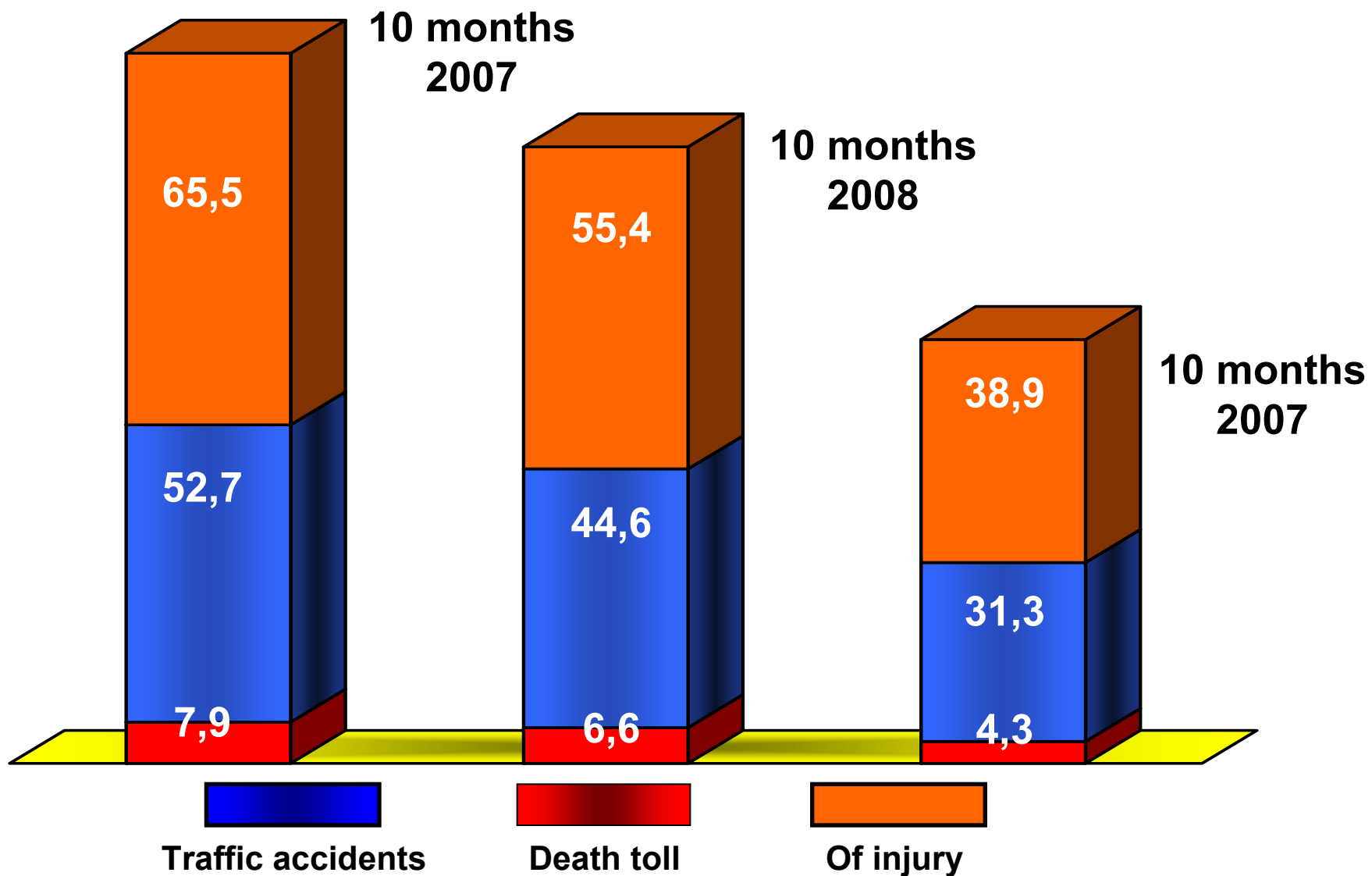

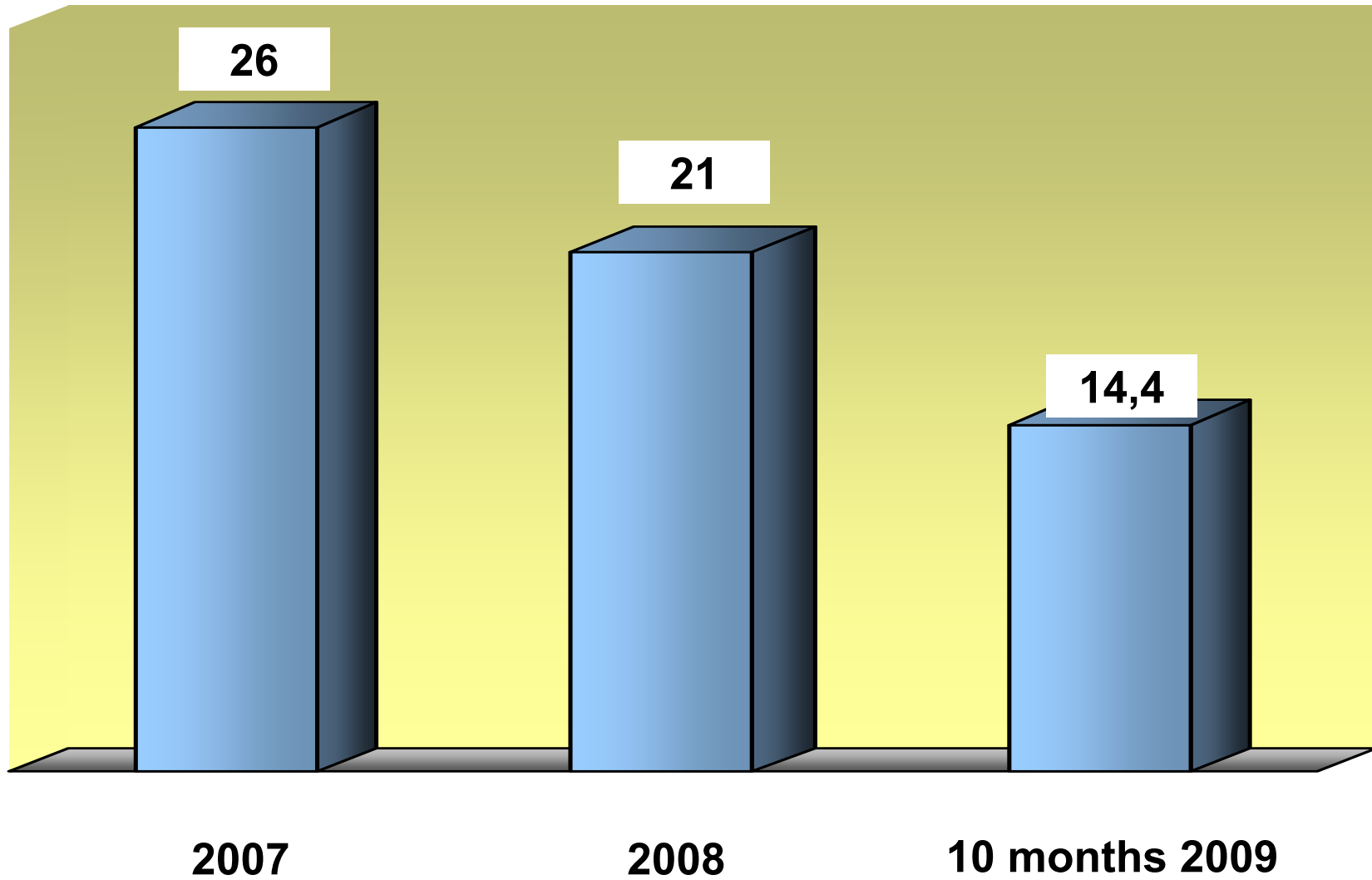
Number of dead in road accident (monthly) in 2007-2008, 10 months in 2009 and forecast through 2009



Dynamics of accidents on highways in 2008 - 2009 years (in thousands)

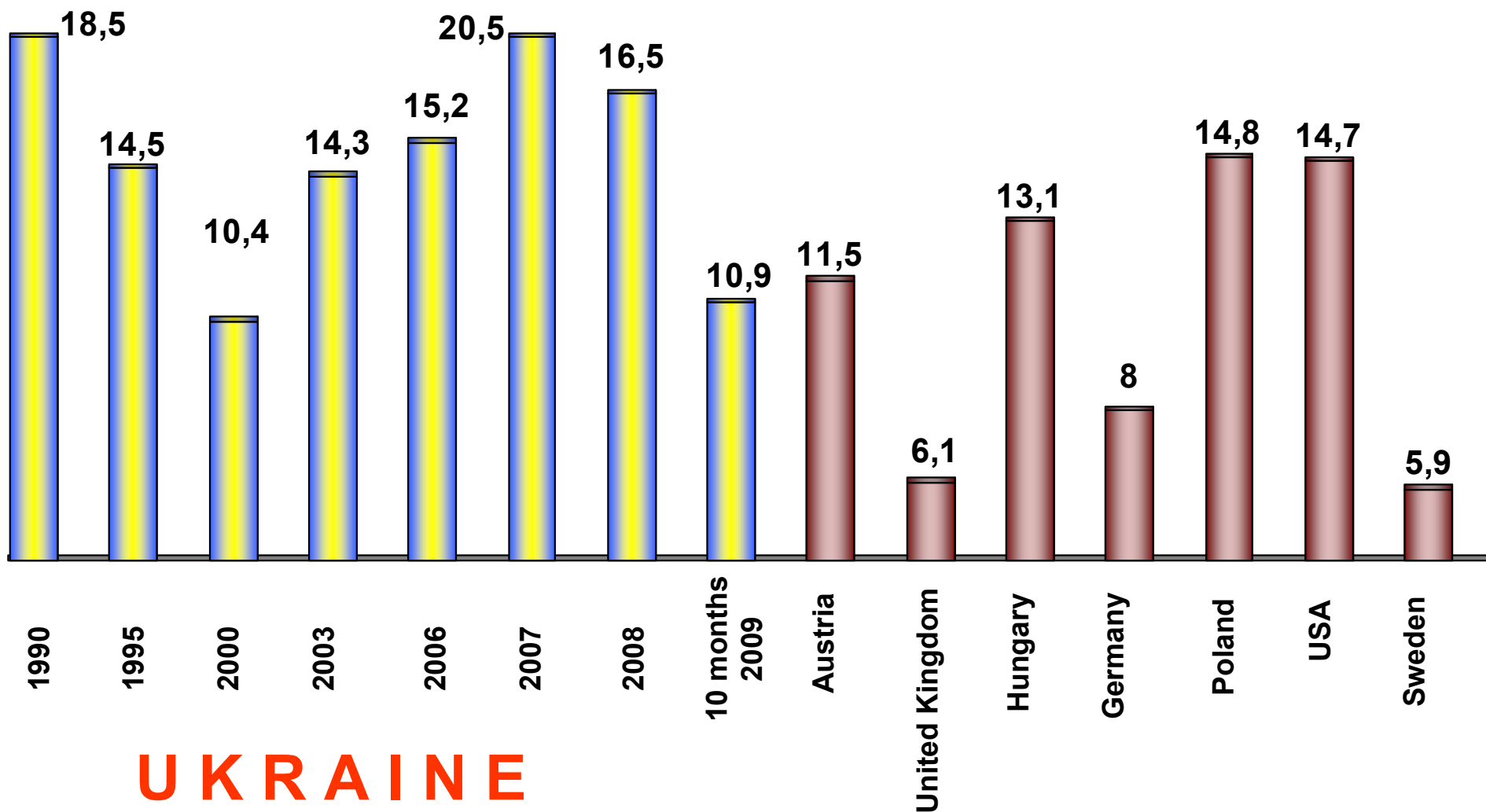


The average number of deaths in road accidents per day

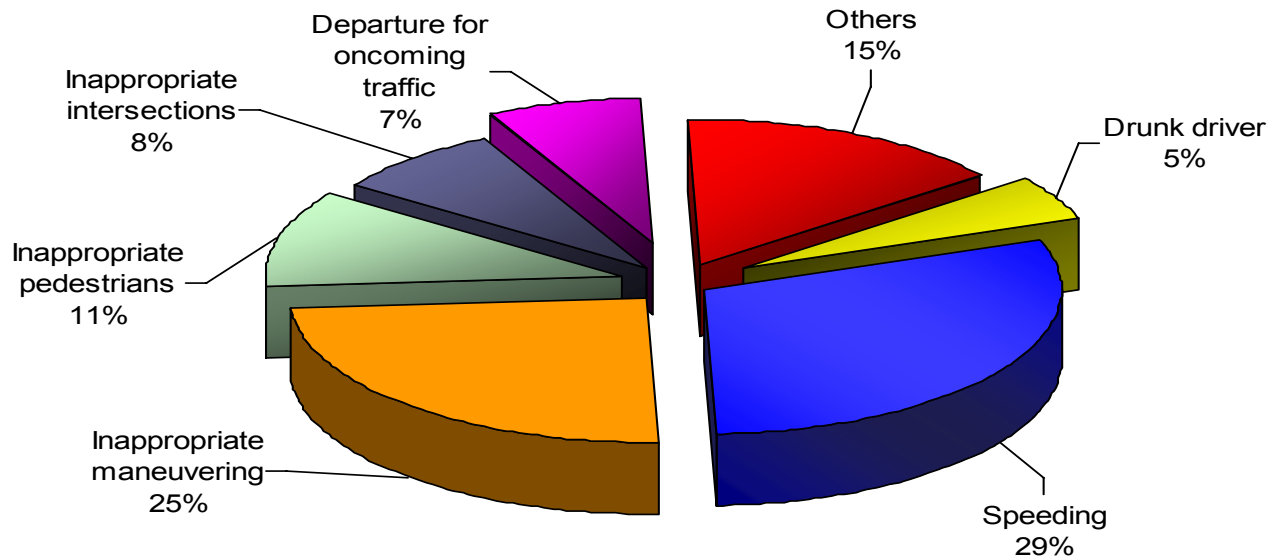


The severity of the consequences of road accidents

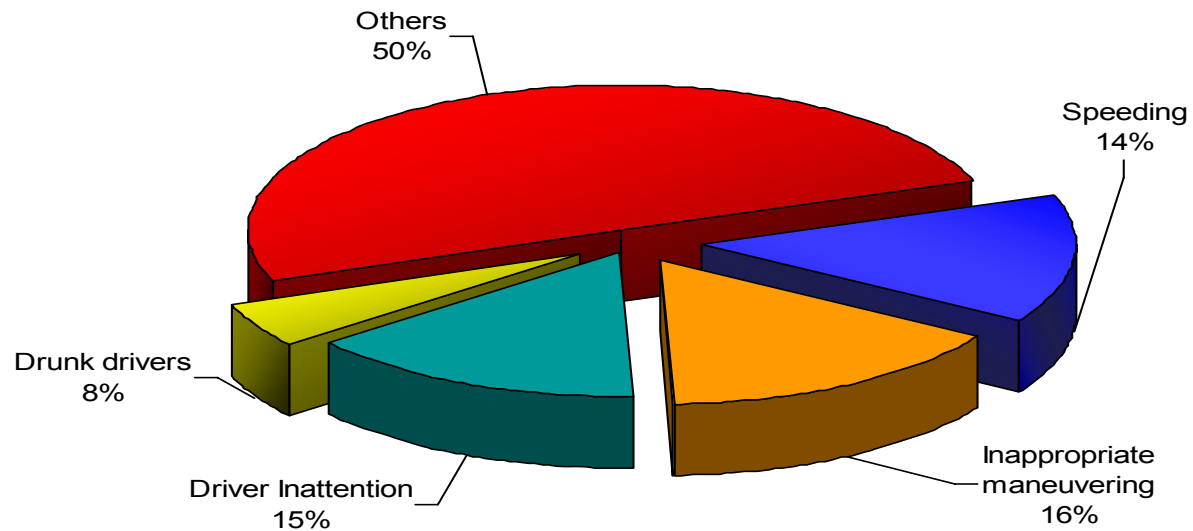
Number of deaths per 100 thousand inhabitants



The causes of road accidents in Ukraine



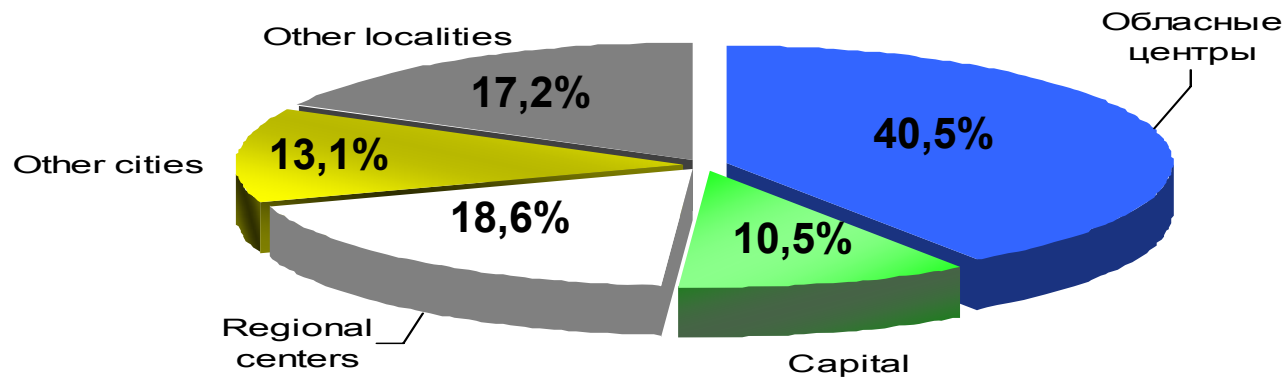
The causes of road accidents in Germany



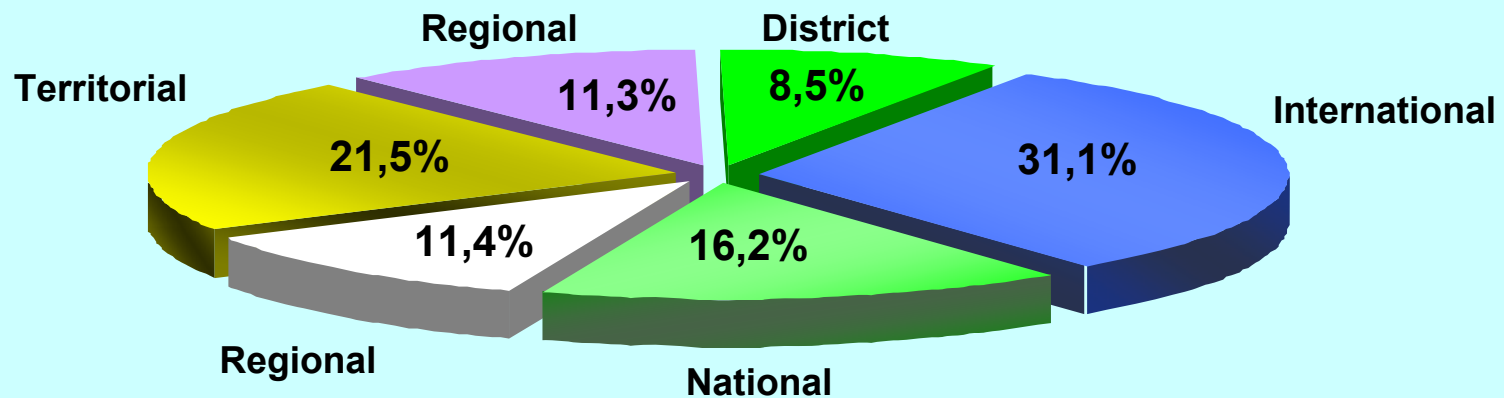
Road traffic accidents on local commission for 10 months in 2009

72% - in settlements


Distribution of road traffic accidents on Human Settlements

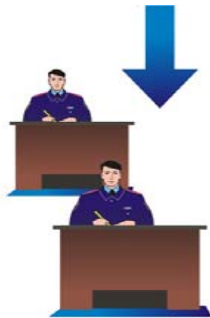
1. Traffic supervision	<p>A focus on identifying violations of the traffic police:</p> <ul style="list-style-type: none">- speeding;- driving while intoxicated;- overtaking rules;- rules intersections;- travel red lights;- failure to comply with pedestrian traffic.
