Environmental monitoring

- Sharing of good practices and experiences on environmental monitoring (including use of new technologies such as Earth observation) during sessions of the Working Group and workshops
- Support to closure of monitoring gaps as identified in the 7th pan-European environmental assessment
- Revision of the 2003 publication "Environmental Monitoring and Reporting : Eastern Europe, the Caucasus and Central Asia" to be started → Terms of reference for a consultant to support the revision under preparation

Support to implementation of SEIS and open data principles

- Working Group agreed in 2022 to review annually a limited number of environmental themes and indicators based on SEIS assessment framework & revised UNECE indicator guidelines
- Agreed to review in 2023 the theme "air pollution and air quality" followed by the theme "waste" in 2024
- Also supporting Nicosia outcomes on SEIS and open data
- Invitation for SEIS reporting on theme air sent to all members of CEP on 4 September 2023
- To date (only) 12 country replies received
- Guidance from CEP on next steps would be appreciated, e.g., whether to wait for more replies and about timing?
- In a next step the report compilation will start

Nicosia Declaration: We invite countries to continue their efforts to implement all pillars of SEIS – content, infrastructure and cooperation – and to address any remaining gaps.



Support to environmental reporting

• Sharing of good practices on environmental reporting during sessions of the Working Group and workshops

e.g., training / guidance sessions on reporting under Water Convention and SDG 6.5.2, Air Convention (emission inventories), monitoring and reporting under Convention on Biodiversity, specific training on air theme

- Support to development of a National State of the Environment Report in Uzbekistan (together with UNEP)
 - Methodology developed
 - Training held
 - Support to actual drafting of the report → soon to be finalized
 - Next steps: To develop an online version of the report (mainly by UNEP)



National State-of-the-Environment Reports

Information on quality of the environment and environmental pressures, in the context of economic development and policy responses

- Provides timely information for decision-makers and the public
- Continuous process: setting targets, monitoring, data analysis, reporting, setting targets...

Approaches and ideas on content:

- Indicator-based assessment proved to be useful and welcome in 7th assessment (use similar set of indicators to track progress but also new ones to monitor emerging themes)
- Closure of gaps needed as revealed in 7th assessment
- Besides traditional themes addressed (states and trends of air, biodiversity, water ...) also integrated chapters (health, nexus..)?
- Monitoring of progress towards policy targets and 7th assessment
- Foresight chapter (scenario building)


Approaches and ideas on process:

- Timeline: Next Ministerial Conference scheduled for about 2027? Preparation of the assessment should stan in 2025?
- Involvement of Working Group experts in drafting and review?
- Organizations to be involved: UNECE, UNEP. Also, EEA? OECD?
- Links with GEO-7? no
- Digital product only?

- Draft timetable of activities for 2024 available under: ECE/CEP/AC.10/2023/4
- Mobilization of resources & assistance from countries & organizations needed to support the implementation of its mandate and terms of reference
- Working Group will collaborate closely with national & international governmental & non-governmental stakeholders & other UN bodies to implement its activities.

Programme area 3: Strengthening of Partnerships

Programme area 4: Engage in capacity-development assistance

Regular convening of Working Group sessions

- 25th session of the Working Group took place on 2-3 May 2023 in Geneva and online
- Topics included:
 - Relevant outcomes of the Ninth EfE Ministerial conference & 7th pan-European environmental assessment
 - New mandate and terms of reference (2024-2028)
 - Recent developments related to environmental monitoring and good practices
 - Reporting (incl. under MEAs)
 - Capacity development activities
 - Progress in environmental monitoring and assessment at national level
- 85 registered participants (from 26 countries)

Outcomes of 25th session

Vice-Chairs

 Took note of the outcomes of the 9th EfE Ministerial Conference, confirmed its commitment to support the implementation of the outcomes subject to availability of resources, and decided to integrate the outcomes into its work

The Working Group:

- Approved the new mandate and terms of reference for the period 2024– 2028 - now put before CEP
- Welcomed the expression of interest by the representatives of Austria and of Georgia in co-leading activities related to air quality
- Invited other members of the Working Group to express their interest in leading or co-leading an activity or area
- Adopted the timetable of activities for 2024 (ECE/CEP/AC.10/2023/4)
- **Requested its members and the secretariat to continue fundraising** to enable the full implementation of activities planned for 2023–2024, including revision of the ECE Environmental Monitoring Guidelines and holding of next sessions
- Welcomed its five-year outline of activities for the period 2024–2028

Outcomes of 25th session

The Working Group:

- Adopted the outline of the report on the Shared Environmental Information System review of the theme "air" (ECE/CEP/AC.10/2023/5)
- Agreed to review the theme "waste and, as appropriate, circular economy" in 2024
- Requested the secretariat to assess the possibility of organizing a regional training event on the revised ECE waste indicators, possibly within the framework of the EU-funded programme EU4Environment – Water Resources and Environmental Data
- Suggested sharing good practices, including on open data platforms, the collection of local and Indigenous knowledge, citizen science and the use of crowdsourced data, during regular sessions of the Working Group, and organizing training and guidance, subject to availability of resources

Working Group

Working Group Outcomes of 25th session

The Working Group:

- Welcomed ideas and approaches for planned 8th pan-European environmental assessment and requested the secretariat, together with the Working Group members, to develop a draft concept to be presented at the next session
- Welcomed presentations on monitoring and reporting by secretariats of ECE Water Convention and Convention on Biological Diversity
- Supported the proposal to review the 2003 Guidelines on Environmental Monitoring and Reporting and requested the secretariat to prepare the revised 2003 guidelines as an official publication in English, French and Russian

Next steps: Follow-up on new mandate and terms of reference and 5-year outline of activities, subject to the availability of resources

Environmental Monitoring and Assessment Programme Resources

Current situation

UNECE

- **Current donors:** Austria and Switzerland, and European Union via the EU4 Environment Water Resources and Environmental Data project
- Sufficient resources to support participation of experts from Central Asia in 26th WGEMA session in April 2024 and initiate a consultancy for reviewing the 2003 publication "Environmental Monitoring and Reporting"
- Insufficient resources for other activities including for participation of experts from other parts of the region in upcoming meetings of the Working Group and the Joint Task Force

Needs

- **Diversification of financial contributions needed** (programme currently dependent on generosity of two countries, outside of projects)
- Member States urged to consider how they can provide financial contributions including for the 8th pan-European environmental assessment to be developed starting from 2025
