



Phase 1: Pre-Closure Planning 10- 18 months	Strengthen policies, institutions, inclusive processes, and build vision / strategies for macro-economic & socio- economic transformations	Pre-layoff social protection assessments & planning, labor profiles, user-needs	Assessing land & assets, preparing for reclamation and re-purposing, resourcing ENV remediation costs	Grants, Reimbursable Advisory Services (RAS), and initial MPA or small IPF concessional lending
Phase 2: Closure 2+ years	Coordinating closure /decommissioning activities between enterprise and agencies	Social assistance to workers & communities, re-skilling, Active Labor Market Policies	Implementation of appropriate technical standards, transfer of assets, mitigation of methane	Grants, RAS, MPA including other MDBs and/or bilateral development agencies
Phase 3: Regional Transition 10+ years	Special Purpose Entity coordinating transition project implementation, managing funding sources	Longer term re-skilling, education, Active Labor Market policies, preparing workers for Future Jobs	ENV remediation of select land & assets by private / public sector, re-permitting and repurposing for private investors to sustain regional transformation	Grants, MPA including other MDBs and/or bilateral development agencies, NGOs, private sector
