0. INTRODUCTION

This specification provides the definition of the Social security claim decision message (SSCLDE) to be used in Electronic Data Interchange (EDI) between trading partners involved in administration, commerce and transport.

1. SCOPE

1.1 Functional Definition

The SSCLDE message is sent by a social security institution or organisation to another social security institution or organisation to provide the decision taken on a claim.

1.2 Field of Application

1.3 Principles

This message enables the transmission of information relating to a person, members of his family or related persons. For each person it enables the transmission of:

- person's identification information,
- person's related data,
- registration information,

- insurance and insurance benefit related information,  
- periods of insurance, registration, employment, etc.  
In the summary section it provides the possibility to make  
reference to a claim or a document on which a decision was  
expected and provide details about the decision.
