## (c) Recommendations on Harmonized Europe-Wide Technical Requirements for Inland Navigation Vessels (Resolution No. 61, revised)

At its fifty-second session, the Working Party decided to postpone to its next session the discussions on the amendment proposals to Resolution No. 61 (ECE/TRANS/SC.3/2015/8, ECE/TRANS/SC.3/2015/9 and ECE/TRANS/SC.3/WP.3/2018/5) and the proposals for harmonizing the technical prescriptions for inland vessels in Resolution No. 61 with the European Standard laying down Technical Requirements for Inland Navigation vessels (ESTRIN) (ECE/TRANS/SC.3/WP.3/2017/18, ECE/TRANS/SC.3/WP.3/2017/14, ECE/TRANS/SC.3/WP.3/2017/15, ECE/TRANS/SC.3/WP.3/2017/16, ECE/TRANS/SC.3/WP.3/2018/6).

The Working Party may wish to continue the discussion on aligning Resolution No. 61 with the 2017 edition of ES-TRIN prepared by the European Committee for drawing up Standards in the field of Inland Navigation (CESNI), on the basis of documents ECE/TRANS/SC.3/WP.3/2018/6 and ECE/TRANS/SC.3/WP.3/2018/15.

The secretariat will inform the Working Party about the consolidated version of the 2015 edition of ES-TRIN in the Russian language.

The Working Party may wish to consider document ECE/TRANS/SC.3/WP.3/2018/16 transmitted by the Confederation of European Maritime Technology Societies (CEMT) and discuss the formulation of new requirements for units with specific characteristics independent from the navigation zones (in particular, for day trip vessels not exceeding 24 metres in length and authorized to carry up to a maximum of 150 passengers) (ECE/TRANS/SC.3/WP.3/2018/16).

# 5. Promotion of River Information Services and other Information and Communication Technologies in inland navigation

## (a) Guidelines and Recommendations for River Information Services (Resolution No. 57)

The Working Party will be informed about the status of the River Information Services (RIS) Guidelines of the World Association for Waterborne Transport Infrastructure (PIANC) (edition 2018) currently being prepared by PIANC Working Group 125.

SC.3/WP.3 may wish to start updating Resolution No. 57 on the basis of the revised PIANC RIS Guidelines

### (b) Application of Inland Automatic Identification System

The Working Party will be informed about the application of Inland Automatic Identification System (AIS) by member States, in particular, the evaluation of answers to the questionnaire on the obligation of fitting inland vessels with an Inland AIS device and a chart display system circulated by the Central Commission for the Navigation of the Rhine (CCNR).

## (c) Updating the United Nations Economic Commission for Europe Resolutions of relevance to River Information Services

The Working Party will be informed about the current status and updates to the Recommendations on electronic chart display and information system for inland navigation (Inland ECDIS) (Resolution No. 48), the International Standard for Tracking and Tracing on Inland Waterways (VTT) (Resolution No. 63), the International Standard for Electronic Ship Reporting in Inland Navigation (Resolution No. 79) and the International Standard for Notices to Skippers (Resolution No. 80). Based on this progress, SC.3/WP.3 may wish to consider updating Resolutions Nos. 48, 63, 79 and 80 in cooperation with the International RIS Expert Groups.

The Working Party may wish to exchange information about the implementation of RIS by Governments and River Commissions.

The Working Party may wish to consider the terminologies used in the ECE region for estimating construction costs of inland waterways on the basis of the questionnaire sent to member States and River Commissions.
