Dear Mr. Zimmermann,

Thank you for the letter from Ms. Kotting-Uhl addressed to the Implementation Committee under the Espoo Convention, expressing concerns regarding the compliance by the United Kingdom with its obligations under the Convention with respect to the planned construction of a nuclear power plant Hinkley Point C.

This is to inform you that the letter was brought to the attention of the Committee at its meeting that was held in Geneva last week. The Committee invited me to inform you that there is a specific procedure under the Convention to allow for the representatives of the civil society to bring information to the Committee's consideration, which consists of filling in the below form and returning it to the Convention secretariat together with any supporting information (The form is also available on the Convention website at: http://www.unece.org/env/eia/implementation/implementation_committee.html). Kindly note that the information should be submitted in English, which is the working language of the Committee.

Once the Committee receives the information, the Committee will consider the information as soon as possible at its subsequent session and then to write to the Government of the UK to seek further information and clarifications, which it will again consider at its subsequent session. In some cases the Committee also contacts the source of information and other potentially affected Governments. Should the responses received not be sufficient, the Committee will continue gathering information until it is able to draw its conclusions. In the end, the Committee can either conclude that there are no grounds for it to pursue the matter further or alternatively, if it considers that the information can be "the basis for a profound suspicion of non-compliance" it may start a "Committees Initiative". This would involve inter alia conducting a hearing of the representatives of the Government and then drafting findings and recommendations that will be submitted for adoption by the Meetings of the Parties.

I hope that I have managed to clarify the above procedure under the Convention. Please do not hesitate to get back to me should you need any further informatino
