ADMINISTRATION OF THE TIR EXECUTIVE BOARD (TIREXB)

Budget of the TIRExB and the TIR secretariat for the year 1999

Note by the TIR Secretary

- 1. The budget and cost plan for the TIR Executive Board (TIRExB) and the TIR secretariat for the year 1999, including the Operating Reserve Fund (15% of total budget) and the programme support (13% of total budget), amounted to US\$ 698,880.
- 2. As of 31 July 1999 less then 42% of the total net allotment for 1999 (total budget net of programme support and Operating Reserve Fund) have been utilized. This is mainly due to the fact that the TIRExB and the TIR secretariat have become operational only in February 1999, that the recruitment of personnel for the TIR secretariat has been completed only in June 1999, that part of the estimated costs have been carried in 1999 by the United Nations (in particular the cost for premises) and that the available resources have been utilized very efficiently.
- 3. The TIR Secretary presents below a detailed report on the financial situation of the TIRExB and the TIR secretariat as of 31 July 1999. Allotments refer to the resources estimated in 1998 and available in 1999; expenditures cover disbursements and obligations already made for future expenditures during the remainder of 1999.

Specification of expenditures (31 July 1999)

Project Personnel (1100)

Three experts recruited on fixed-term appointments (until 31 December 1999).

2 days consultancy to set up the TIR web site on the Internet.

Administrative Support Personnel (1301)

This budget line has been established in May 1999, following consultations with the IRU, to allow for the temporary recruitment of personnel for the entry of data on authorized persons utilizing TIR Carnets (International TIR Data Bank). This proved to be necessary as only some Contracting Parties and national associations were in a position to make use of the data entry mask established and distributed by the TIR secretariat.

Official travel (1500)

One mission of one Customs expert (Finnish/Russian border (June/July 1999)).

Two missions of the TIR Secretary (German/Polish border (June 1999); Finnish/Russian border (June/July 1999)).

Mission costs (1600)

Per diem for the participation to 2 TIRExB members at two meetings of the TIRExB in Geneva.

Premises (4300)

In 1999, the United Nations has provided the necessary office space for the TIR secretariat free-of-charge on the basis of an informal arrangement. US\$ 20,000 of the amount originally allotted under this budget line, have been transferred to the newly created budget line "Administrative Support Personnel" (1301) (see above).

Local procurement (4500)

Electronic and computer office equipment (4 personal computers, 3 printers, 1 portable computer and 1 portable printer) have been purchased, including required software packages.

Operation and maintenance of equipment (5100)

No cost occurred so far under this budget line as the equipment is still under guarantee.

Sundry (5300)

This budget line has not yet been used.

Expenditures foreseen for the remainder of 1999

In the remaining five months of 1999, it is expected that the major part of the allotments for the year 1999 will be used with the following exceptions:

(a) <u>Project Personnel (1100)</u>

The three experts charged against this budget line have been recruited in February 1999, March 1999 and June 1999 respectively. Thus considerably lower expenditures than estimated will occur under this budget line.

(b) Mission costs (1600)

Only a few members of the present TIRExB require financial support for the attendance of meetings of the TIRExB. Thus it is estimated that a large part of the allotted amount will not be needed in 1999.

- (c) Premises (4300) (see above)
- (d) Operation and maintenance of equipment (5100) (see above).

As a result, it is estimated that the budget for the year 1999 will close with a positive balance of at least: US\$ 300,000. To this amount the 15% Operating Reserve Fund (US\$ 81,900) has to be added which however also has to be re-established for the budget in the year 2000.

It should be noted that this rather large estimated positive balance will most likely not occur in the following years as it is mainly due to the late coming into operation of the TIRExB and the TIR secretariat in 1999.
