In accordance with the request made by the Working Party on Road Transport (SC.1) at its ninety-fifth session, the secretariat has requested in writing the opinion of the Contracting Parties to the CMR by means of a questionnaire prepared by UNIDROIT (contained in document TRANS/SC.1/2002/1) on the specific follow-up to its draft additional Protocol, and particularly on the best solution to implement in the context of the CMR (TRANS/SC.1/369, paras.44 and 45). The analysis of the replies is given in the attached table.

¹ Express the idea to read: "By any other means of transmitting information, by electronic or other similar means of communication [...]."

- 2ter Express the idea to read: "The procedure used for the registration and treatment of the consignment note established in a different form must be equivalent from the functional point of view, particularly so far as concerns the evidential value of the consignment note ...".
- ³ Add the following idea: "This also means that, at any moment, at the request of the authorities, the data may be transformed into legible written symbols (printed)".
- ⁴ Express the idea to read: "provided the information <u>is filed in such a way</u> that it is accessible <u>to the persons and authorities concerned</u> <u>and to others</u> so as to be usable for subsequent reference, <u>even where they do not have access to the necessary electronic equipment.</u>"
- ^{4bis} ,from the functional point of view, Express the idea to read: "The procedure used for the registration and treatment of data must be equivalent, from the functional point of view, to the paper-based version of the consignment note, particularly so far as concerns the equivalent value of the consignment note represented by these data."
- ⁵ Agrees with the new §3 provided that the procedure mentioned in article 5 §1, which provides for the need for the goods transported to be accompanied by a copy of the contract of carriage, is taken into consideration.

^{2bis} Express the idea to read: "provided the consignment note can <u>remain subsequently usable as a source of original information</u>".
