**MISCELLANEOUS AMENDMENTS TO RID/ADR**

- 1.2.1 Should the definition for "Frame" (see Bundle of cylinders) be kept? In the old definition of "Bundle of cylinders", "Frame" was considered a synonym, but the Joint Meeting adopted a new definition for "Bundle of cylinder" in which no reference is made to frame.[Applies only to the English version]

**UN No. 1043 FERTILIZER AMMONIATING SOLUTION with free ammonia**

The Joint Meeting decided that this entry of the Un Model Regulations should not be used because the packing conditions for such solution were unknown. As a result UN No. 1043 is not authorized for carriage in the RID. In the ADR special provision 642 was assigned, which excluded the use of this UN number except for carriage in a transport chain including maritime or air carriage. But as this UN number is used in the IMDG code and the conditions of carriage have now been defined (packing instruction P200), and included in RID/ADR, the Joint Meeting may wish to consider authorizing the use of this entry, i.e.:

Consequential amendment for ADR: delete special provision 642.

#### 4.1.4.2

Under packing instruction IBC02, the Joint Meeting adopted special packing instruction B11 for ADR/RID 2001 versions. This special packing instruction, which was also renamed as BB1 afterwards (see TRANS/WP.15/AC.1/86/Add.2), to avoid confusion with the UN Recommendations, does not apply to any UN number in Table A. It also does not seem to be a provision of ADR 1999. Should it be deleted?
