# 3. STATUS OF THE EUROPEAN AGREEMENT CONCERNING THE INTERNATIONAL CARRIAGE OF DANGEROUS GOODS BY INLAND WATERWAYS

As of 12 November 2002, the Agreement had been signed (subject to ratification) by 10 States: Bulgaria; Croatia; Czech Republic; France; Germany; Italy; Luxembourg; Netherlands; Republic of Moldova; Slovakia.

The Russian Federation deposited an instrument of accession on 10 October 2002 and is therefore the first Contracting State (depositary notification C.N.1085-2002-TREATIES-1 of 11 October 2002).

The meeting will be informed of any further developments.

#### 4. PROPOSED AMENDMENTS TO THE REGULATIONS ANNEXED TO ADN

#### (a) Proposals pending

The secretariat had proposed a reworded version of 7.1.4.1 at the last session. The Joint Meeting had supported this proposal in principle but had expressed the wish to be able to consider it in detail (see TRANS/WP.15/AC.2/1/Add.10 and TRANS/WP.15/AC.2/13, para. 29).

#### (b) New proposals

The secretariat has prepared documents TRANS/WP.15/AC.2/2003/1 and -/3 on the basis of the amendments made to ADNR by Resolution No. 2002-I-37 of the Central Commission for the Navigation of the Rhine.

The Government of Belgium has submitted a proposal relating to Part 5 (TRANS/WP.15/AC.2/2003/2).

### 5. MATTERS RELATING TO THE RECOGNITION OF CLASSIFICATION SOCIETIES

The Joint Meeting will be informed of any applications for recognition submitted by classification societies.

#### 6. PROGRAMME OF WORK AND CALENDAR OF MEETINGS

The eighth session of the Joint Meeting is scheduled for 26 to 30 January 2004. The secretariat will submit proposals for the programme of work.

### 7. ANY OTHER BUSINESS

No proposals have been received in connection with this agenda item.

### 8. ADOPTION OF THE REPORT

In accordance with its usual practice, the meeting will adopt the report of its seventh session on the basis of a draft prepared by the secretariat.
