ECA TRANSPORT PROJECTS

1. Four new transport loans have been signed in 2006 calendar year, three of which are with Central and Eastern European (CEE) countries and one in the Caucasus. All four are financed by International Bank of Reconstruction & Development (IBRD) totaling to US\$635 million. In addition, International Development Association (IDA) Grant of US\$ 5million was signed with Georgia for facilitation of infrastructure investments in energy and transport sectors. One more IDA loan is expected to be signed by the end of 2006 with Georgia for US\$19 million. Fifteen loans are anticipated to be signed in 2007 calendar year, of which four would be financed by IDA (total of US\$89 million), ten by IBRD (total of US\$1,036 million), and one by IBRD/IDA (US\$20 million and USD\$5 million).

2. The main trends observed in 2006 lending activities compared to those in 2005 and prospects for 2007:

- Number of loans signed as well as total dollar amount has almost doubled since 2005.
- Main focus of majority loans signed in 2005 was directed toward railways (two of three), while in 2006 the focus has shifted toward roads and trade/transport facilitation (TTF) activities.
- Increased trend of focus on trade and transport facilitation is seen in the pipeline projects.
- Recipients of loans in both years, 2005 and 2006, were primarily middle-income EU accession countries (IBRD financed loans), while in 2007 prospects the growing trend of lending activities is seen in low-income countries (IDA financed loans).
- Compared to 2005, the lending activities in the South Caucasus are increasing with one loan and one grant signed in 2006, one to be signed by the end of 2006, and four under preparation.
