Information on work in progress in CEN

Transmitted by the European Committee for Standardisation (CEN)

As agreed at the September 2005 session, the CEN consultant will advise the Joint Meeting of work in progress in CEN which will result in standards intended to be referenced in the RID/ADR/ADN.

The table in the Appendix (English only) lists all the new (Step 1 of the Approval process) relevant Work Items (WI) from CEN Technical Committees 023, 256, 261, 268, 286 and 296 that are preparing standards for reference in RID/ADR/ADN. The character of work has been added in order to allow a better judgement.

A large part of the new work items follows the move to ISO, i.e. the establishment of EN ISO standards, to be referenced first in the UN Model Regulations.
