Report of the 13th meeting of the informal working group on the training of experts

Transmitted by the Central Commission for the Navigation of the Rhine (CCNR)¹

1. The informal working group on the training of experts held its 13th meeting on 29 and 30 September 2014 in Hamburg, under the chairmanship of Mr. Bölker (Germany). Representatives of the following States took part in the meeting: Austria, Germany and Switzerland. The following non-governmental associations and training organizations were represented: International Committee for the Prevention of Work Accidents in Inland Navigation (CIPA), as well as Binnenschiffer-Ausbildungs-Zentrum, Germany, and Maritimes Competenzcentrum, Germany.

II. Calendar of work

3. The informal working group noted that the most recent version of the calendar of work dated from 2012 and should be amended for the next ADN cycle. It requested the CCNR secretariat to submit a redrafted version of the document to the ADN Safety Committee.

C. ADN 2015 (item 1.3 (new) of the calendar of work)

- 7. The informal working group redrafted the questions with comments of the catalogue of questions on general issues. Mr. Bölker noted that, to be official, documents needed to be sent to Geneva by the end of October.
- 8. The secretariat was requested to amend the spelling of the "oxydierend" to "oxidierend" in the German catalogue of questions on general issues.
- 9. The Federal Institute for Materials Research and Testing (Bundesanstalt für Materialforschung und -prüfung) agreed to carry out a quick check of some questions from the catalogue and communicate the results to the Chairperson, who would then transmit the remarks to the secretariat for inclusion in the catalogue of questions.
- 10. The group decided that, as a general rule, all sources would be indicated in the questions.
- 11. The questions on emergency exits proposed by the Netherlands delegation could not be considered as they were not available to all the participants. The group decided to request the secretariat to send the proposals out as an official document and to postpone inclusion of the questions to the 2017 catalogue.
- 12. The working group redrafted the questions with comments from the catalogue of questions on chemicals.
- 13. The group checked the use of the terms "density" and "relative density" and corrected some of the questions in the catalogue.
- 14. The Federal Institute for Materials Research and Testing (Bundesanstalt für Materialforschung und -prüfung) agreed to carry out a quick check of some questions from the catalogue and communicate the results to the Chairperson, who would then transmit the remarks to the secretariat for inclusion in the catalogue of questions.
- 15. The secretariat was asked to check the use of commas after paragraph numbers in the catalogue of questions. In the case of references, no comma should be placed after a paragraph number that was followed by text.
- 16. The working group redrafted the questions with comments from the catalogue of questions on gases.
- 17. The group decided that, as a general rule, calculators would be permitted during the examinations. The training organizers confirmed that that was already the case in practice.
- 18. The definitions of the terms "sampling device" and "test tube" and the use of such equipment were discussed. It was found that the use was not defined in ADN.
- 19. The Federal Institute for Materials Research and Testing (Bundesanstalt für Materialforschung und -prüfung) agreed to carry out a quick check of some questions from

the catalogue and communicate the results to the Chairperson, who would then transmit the remarks to the secretariat for inclusion in the catalogue of questions.

20. For the 2017 catalogue of questions, the group decided to check whether bar should be replaced by kPa as the unit of measurement for pressure.
