## Classification system for transport statistics

### I. Background

NST 2007 (Standard Goods Nomenclature for Transport Statistics) replaced the CSTE nomenclature (Commodity Classification for Transport Statistics in Europe - UNECE) and the NST/R nomenclature (Standard Goods Nomenclature for Transport Statistics/revised - Eurostat).

<sup>3</sup> Examples for group 01.7:

- Christmas trees (CPA2008 01.29.20)
- Energy wood, salix, normally grown on farms instead of cereals
- Seed that is prepared with or without chemicals for growing new plants

<sup>4</sup> Examples for group 01.A:

- Raw hides and skins (CPA2008 01.49.3) if the skinning does not take place in a slaughter house
- Manure
- Eggs, fresh from a farm (CPA2008 01.47.2)

<sup>5</sup> Examples for group 04.1:

- Raw hides and skins (CPA2008 10.11.4) if the skinning takes place in a slaughter house

<sup>6</sup> Examples for group 04.6 :

- Grain (barley, wheat ...) processed for animal – but not human – feed

- Tar paper, used on roofs and for other building purposes

- Road vehicles for repair, as well as towed vehicles

- Small sheds used for the personnel at construction sites, with or without wheels
