INFORMATION FOR PARTICIPANTS

1. <u>Visas:</u> Delegates from Armenia, Azerbaijan, Belarus, Georgia, Kazakhstan, Kyrgyzstan, Uzbekistan, Tajikistan, Russian Federation, Moldova, Poland and Hungary do not need a visa to enter the territory of Ukraine. Delegates are advised to present to the Customs officials the letter of invitation and confirmation of their official travel. Delegates from Bulgaria, Estonia, Lithuania, China, Latvia, Slovakia, Turkey, Croatia and Turkmenistan having a diplomatic passport, do not need a visa either.
