Expert meeting on theUNECE PPP Toolkit, Deloitte, London , United Kingdom , 14 May 2009

The UNECE held an expert meeting to review work already accomplished and to discuss the modules still to be started as part of the collective work to elaborate its toolkit on "How to do PPPs". Enhancing professional skills in PPPs in the Russian Federation

Asian-pacific region, mainly from the public sector.

The conference shared global PPP practices and lessons learned among PPP policymakers and program managers in order to improve the design and implementation of PPP programs across the Asia Pacific region and to achieve greater access and more cost effective infrastructure service delivery. It profiled an in-depth assessment of the Korean PPP experience and contrasted Korea's PPP policies and sector approaches with practice from selected countries globally. It also organized a site visit to a number of actual ongoing PPP projects in Korea that demonstrate this country's impressive progress with the PPP model, including the "Incheon Bridge" which provides direct access between Songdo and Incheon International Airport.

The UNECE secretariat gave a presentation on the impact of the financial crisis on public private partnerships. The presentation argued that the critical affect of the crisis was the difficulties to receive long-term funding from the banks. Remedial actions to bring back the banks into PPPs through stimulus packages had not appeared as yet to be working. It also argued that the crisis had presented an opportunity to mainstream PPPs as a more social orientated tool and with more emphasis on accountability, transparency and sustainable development.



This Newsletter provides information on the work of the UNECE Team of Specialists on Public Private Partnerships (PPPs) as it concerns capacity building and other related activities. 3. To create a more effective framework for international cooperation on PPPs – a PPP Centre or something like this - that can ensure regular contacts between key stakeholders, that can increase the capacity of governments to deliver PPPs, that can build local training capacity and can keep up to date the PPP training materials.

For our second issue and beyond, the Newsletter will publish articles demonstrating progress towards the achievement of these 3 goals. However your support is vital if we are to achieve these objectives.
