I. PREAMBLE

The United Nations, through its Centre for Trade Facilitation and Electronic Business (UN/CEFACT), supports activities dedicated to improving the ability of business, trade and administrative organizations, from developed, developing and transitional economies, to exchange products and relevant services effectively. Its principal focus is on facilitating national and international transactions, through the simplification and harmonisation of processes, procedures and information flows, and so contribute to the growth of global commerce.¹

The attached revision supersedes and replaces the code list released as the sixth revision of Recommendation 21, Annex V and Annex VI, (CEFACT/ICG/2008/IC005) approved by the ICG, in May 2008.

II. CODE LIST PRESENTATION

1. The code list is presented with the following columns:

Change indicator (CI)

An indication of the maintenance status of individual entries in the code list.

- a plus sign (+) <u>Added</u>. New unit added in this release of the code list
- a hash sign (#) <u>Changed name</u>. Changes to the unit name in this release of the code list
- a vertical bar (I) <u>Changed characteristic(s)</u>. Changes other than to the unit name in this release of the code list, e.g. a change to the numeric code

a letter X (X)	<u>Marked as deleted</u> . Code entries marked as deleted will be retained indefinitely in the code lists. When appropriate, these entries may subsequently be reinstated via the
	maintenance process
an equals sign (=)	<u>Reinstated</u> . Code entries previously marked as deleted and reinstated in this release of the code list
