CODES FOR TYPES OF CARGO, PACKAGES AND PACKAGING MATERIALS

I. PREAMBLE

The United Nations through UN/CEFACT (United Nations Centre for the Trade Facilitation and Electronic Business) supports activities dedicated to improving the ability of business, trade and administrative organisations, from developed, developing and transitional economies, to exchange products and relevant services effectively. Its principal focus is to facilitate international transactions, through the simplification and harmonization of procedures and information flows.¹

The UN/CEFACT work-program emphasises the need for developing recommendations, which simplify and harmonize the current practices and procedures used in international transactions. Within this context, the role of the UN/CEFACT Information Content Management Group (ICG) is to secure the quality, relevance and availability of code sets and code structures to support the objectives of UN/CEFACT, including managing the maintenance of UN/ECE Recommendations related to codes. The ICG prepared this latest revision of the code list for Recommendation 21.

The attached revision supersedes and replaces the code list released with the fourth revision of Recommendation 21 (ECE/TRADE/309) approved by the ICG, in May 2002.

a letter X (X)	<u>Marked as deleted</u> . Code entries marked as deleted will be retained indefinitely in the code lists. When appropriate, these entries may subsequently be reinstated via the maintenance process
an equals sign (=)	<u>Reinstated</u> . Code entries previously marked as deleted and reinstated in this release of the code list
