2. It was agreed that Bureau members should provide feedback on the draft minutes within two weeks (by cob 15 May).

#### Item 3: Bureau Nominations

3. The Chair summarized the nominations received to date, noting that the European Commission (DG Enterprise and Industry (DG ENTR)) had submitted a nomination on 29 April, notably Ms. Claudia Wulz, Statistical Assistant, DG ENTR. The nomination was discussed and it was noted that the DG ENTR Seconded National Expert, Mr. Slavko Solar, would be acting as Ms. Wulz's alternate. Whilst Mr. Solar is very familiar with UNFC and the Expert Group, his status as a Seconded National Expert means he cannot be the official EC DG ENTR representative on the Bureau. The Bureau discussed the issue of members being able to give delegated authority.

4. The Bureau agreed that efforts should be made to identify an expert to represent African countries. The representative of CRIRSCO agreed to talk with the participants from African countries present at the fifth session to seek their advice on a potential nominee.

5. The need to ensure improved gender balance on the Bureau was raised and noted.

6. The Bureau noted that the National Hydrocarbons Commission of Mexico has expressed interest in submitting a nomination in 2015.

7. The Bureau further noted that nominations might also be received in the meeting room but as yet there had been no indications that this would be the case.

8. The full slate of nominations will be presented by the secretariat to the EGRC on 2 May following which the elections will be held.

9. The draft conclusions and recommendations as revised during the EGRC meeting on 30 April and 1 May were reviewed.
