Dear Mr. Simpson,

I am writing to you on behalf of the Implementation Committee under the Convention on Environmental Impact Assessment in a Transboundary Context (Espoo, 1991).

At its thirty-first session, held in Geneva from 2 to 4 September 2014, the Committee continued its consideration of the information it gathered on its initiative on the United Kingdom of Great Britain and Northern Ireland regarding the planned construction of the Hinkley Point C NPP (EIA/IC/CI/5). The Committee also reviewed the additional information provided by the United Kingdom on 19 June and 20 August 2014.

In the light of all information received, the Committee agreed not to discuss the issue with the United Kingdom at its thirty-second session (9–11 December 2014). I apologize for any inconvenience, which may be caused by this decision.

The Committee also agreed to forward to the United Kingdom the information gathered (enclosed). You are now invited (a) to comment on that information; and (b) to further elaborate on the transboundary procedures concerning the adoption of the nuclear National Policy Statement.

On the basis of the information received, at its next session the Committee will decide whether a new discussion will need to be scheduled in 2015 or whether the Committee will proceed with drafting findings and recommendations in closed session. However, you are invited to comment on this approach and to indicate whether the United Kingdom wishes to avail of its right to participate in a discussion with the Committee and present information and opinions on the matter. In that case, please specify the points that in your view will have to be discussed with the Committee.
