Re: Communication to the Aarhus Convention Compliance Committee concerning compliance by Austria with provisions of the Convention in connection with the construction of a waste incinerator in the province of Burgenland (ACCC/C/2009/39)

On behalf of the Aarhus Convention Compliance Committee, I would like to thank the participants in the discussion of the above referenced communication at the twenty-eighth meeting of the Compliance Committee (Geneva, 15-18 March 2010). Further to the oral submissions of the parties at the discussion in an open session, the Committee deliberated in closed session and held that the communication was not admissible as manifestly unreasonable, because the communicant, having been awarded the status of "neighbour" under Austrian legislation, had submitted all its comments. In the view of the Committee, the communicant failed to substantiate that it was not able to participate in the different stages of the environmental decision-making procedure; or to what extent its important objections to the activity were not considered during this procedure. The Committee's deliberations were communicated to the parties after the discussion.
